**Probable Cause**  
 On Sunday, February 21, 2021, I was dispatched to a rollover collision located on northbound Interstate 95 (State Road 9), south of State Road 794 (Yamato Road). When I arrived on scene I observed a white Infiniti passenger car bearing Florida Tag " facing west in the east grass ditch with damage on all sides from rolling over.

The Driver was identified by her Florida Driver's License (FL DL: B623-013-90-642-0 ) as ASHLEY MARIE BREWSTER, date of birth April 22, 1990. The passenger was BREWSTER's [REDACTED] who identified him as [REDACTED] date of birth March 18, 2012.

[REDACTED] sustained minor injuries which EMS treated on scene.

BREWSTER stated that her husband was a dispatcher for Florida Highway Patrol (FHP). Due to the possibility of [REDACTED] being transported and BREWSTER having to travel with him, I started a rotation tow. Trooper Horlkings Saget located White Claw in the vehicle during the inventory. As the investigation continued, BREWSTER stated her aunt was the supervisor of the dispatchers at FHP and then stated her fiance was a tow truck driver for FHP.

When I asked BREWSTER what happened, she stated she was changing lanes and lost control of the vehicle.

Later in the investigation, BREWSTER called her fiance, BERNARD ANDREW KELLY (FL DL: K400-081-84-286-0), and stated she was in an accident and the vehicle needed to be towed. The vehicle was registered to B. KELLY who is a tow truck driver for All Florida Towing. B. KELLY took possession of the vehicle and [REDACTED] on scene.

I advised BREWSTER I was finished with my crash investigation (see FHP crash report 88410460) and would now be conducting a DUI investigation. I read BREWSTER her Miranda Warnings.

While talking with BREWSTER, I observed she had bloodshot, glossy eyes, lethargic, slurred speech, and was unable to maintain her balance, tripping over herself while walking around the scene. BREWSTER had the keys which were confirmed to start the vehicle when the tow truck driver/ fiance picked the vehicle up.

I asked BREWSTER if she would be willing to perform Standardized Field Sobriety Tasks (SFST's), she stated she would.

I asked BREWSTER if she wore contacts or glasses, she stated she did not. I asked BREWSTER if she was in a crash today, she stated she was. I asked BREWSTER if she had any medical conditions or injuries that would affect any of the tasks. BREWSTER stated from the crash she had some cuts on her legs. I asked BREWSTER to stand in front of my patrol vehicle, so I can capture all the roadside tasks on my state issued in-car dash camera.

There were no debris in the area the tasks were performed and all exercises were explained and demonstrated before BREWSTER performed them in a well light area. The area was illuminated by the patrol car takedown lights and lights on the roadway. The following exercises and clues were performed and observed:

**Horizontal Gaze Nystagmus (HGN):**

I asked BREWSTER if she could see the light on my stimulus, she stated she could. BREWSTER was also able to confirm the light was red. I checked for equal pupil size and equal tracking. BREWSTER's pupil size and tracking was equal.

**I observed the following during HGN:**

- Left eye- Lack of Smooth Pursuit
- Right eye- Lack of Smooth Pursuit
- Left eye- Distinct and Sustained Nystagmus at Maximum Deviation
- Right eye- Distinct and Sustained Nystagmus at Maximum Deviation
- Left eye- Onset of Nystagmus Prior to 45 Degrees
- Right eye- Onset of Nystagmus Prior to 45 Degrees

I also observed BREWSTER had lack of convergence. When attempting to look for vertical gaze nystagmus (VGN), BREWSTER was looking up but moving her eyes side to side.

**Walk and Turn (WAT):**

Solid colored yellow duct tape was used for the task. I explained and demonstrated

the roadside task to BREWSTER. BREWSTER stated she understood and did not have any questions.

BREWSTER could not keep her balance while listening to the instructions on five times. On the 5th time losing balance, BREWSTER stood with her feet side by side until I finished providing instructions. BREWSTER started the task before she was told to begin. BREWSTER made an incorrect turn by removing both feet from the line and turning around. BREWSTER missed heel-to-toe on the 2nd, 4th, 6th, and 8th steps in the first set of steps and on all steps in the second set of steps. BREWSTER stepped off the line on the 1st and 6th steps in the first set of steps and the 6th step on the second set of steps.

**One Leg Stand (OLS):**

I explained and demonstrated the roadside task to BREWSTER. BREWSTER stated she understood and did not have any questions. I used the stopwatch on my watch to time the task for 30 seconds. BREWSTER chose to raise her right leg for the task.

Even though BREWSTER stated she understood the instructions, within the first couple seconds the task had to be re-explained and re-started.

BREWSTER used her arms for balance around 18 seconds for the remainder of the task and raised her arms more than 6 inches from her body. BREWSTER swayed. BREWSTER put her foot down at approximately 5 seconds and almost fell, and again at approximately 18 seconds.

Based upon the totality of circumstances and my training and experience, I placed ASHLEY MARIE BREWSTER under arrest at approximately 1:43 AM for Driving Under the Influence of an unknown alcoholic beverage or unknown chemical or controlled substance. BREWSTER was then placed in handcuffs which were secured, double-locked, and checked for proper tightness for her security and mine. I was able to stick two fingers between the handcuff and BREWSTER's wrist at all times handcuffs were on.

I allowed BREWSTER to remove her jewelry due to the amount she had on her body and her property was released to her fiance on camera with BREWSTER's permission.

A search was conducted on BREWSTER. While on the way to the Palm Beach Sheriff's Office BAT, BREWSTER was caught on my in-car backseat camera pulling a bag out of her vagina and eating the green leafy contents inside the bag which had an odor of Cannibas. When I escorted her out of my vehicle at the jail, other particles of the substance were on the backseat along with the bag the substance was inside of inside my patrol vehicle and the odor of Cannibas smelled stronger when I opened the back door.

I conducted a 20-minute observation period of BREWSTER while in the Breath Testing Center. During this observation period, BREWSTER did not put anything in her mouth or regurgitate. While in the testing room I requested that BREWSTER submit to a breath test in order to determine the alcohol content. BREWSTER stated she would submit to the breath sample. The following are the breath sample results:

Breath sample 1: .100 g/210L  
Breath sample 2: .092 g/210L

The technician explained BREWSTER's results. BREWSTER stated she understood.

BREWSTER was then read his Miranda Warnings per the PBSO BAT procedures. BREWSTER refused to answer the questionnaire provided by the technician.

BREWSTER was transported to the Good Samaritan Emergency Center on Okeechobee Boulevard and Haverhill Road for medical clearance. BREWSTER was medically cleared. While at the emergency clinic, BREWSTER changed her story from her original crash story stating that a vehicle cut her off.

BREWSTER was then booked at the PBSO Jail and custody was handed over to

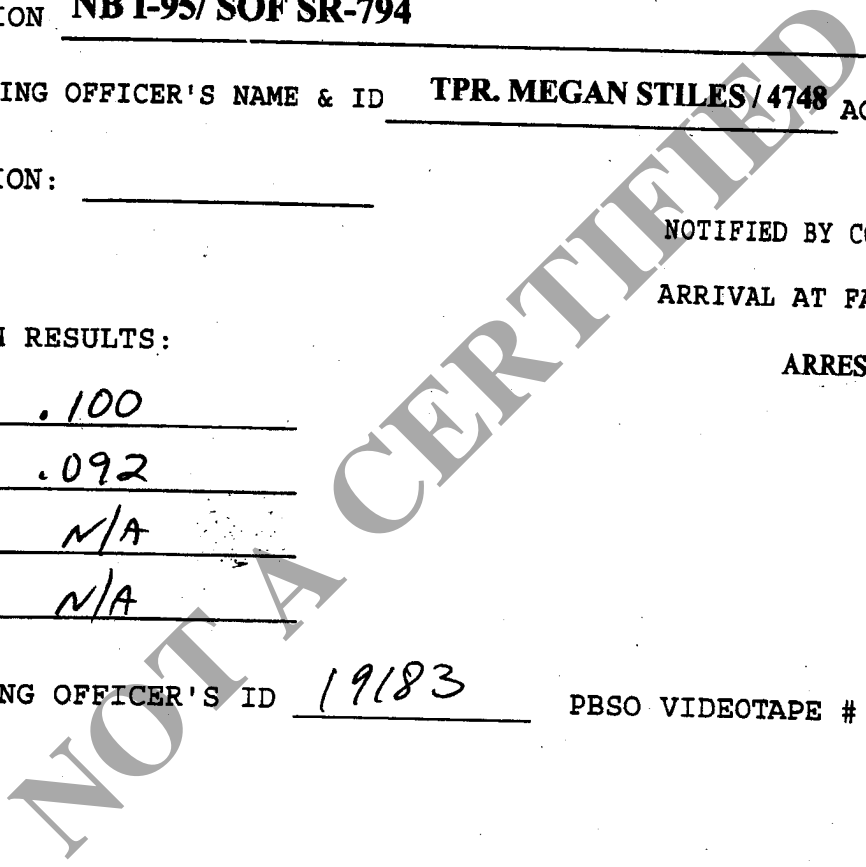
