The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/19/2021 at 0101 hours, suspecting that the driver was either ill, fatigued, or impaired I conducted a traffic stop on a 2011 dark gray Mazda sedan, after I observed the vehicle drifting from side to side as it traveled northbound on Howard Av N from Kennedy Bl W. Upon contact with the driver of the vehicle, defendant Ashley Marie Kaiser, I observed that she had bloodshot glassy eyes and then as I explained to her why I had stopped her I detected a distinct odor of an alcoholic beverage. The defendant then admitted to having "one drink". The defendant then refused to perform the SFSEs. At which time I placed her under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0107 hours. I then transported the defendant to the HCSO/CBT Facility where she refused to submit to a breath test. Implied Consent was read at 0141 hours. I identified the defendant with a valid FL DL.
