The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

I observed the defendant driving a silver Honda with FL tag 269TDD on the roadway. She was speeding, 70 miles per hour in a 50 mile per hour zone. She was following the vehicle in front of her to close and weaving side to side. I conducted a traffic stop and made contact with the defendant who was in the driver's seat. Upon contact with the defendant I could smell the odor of alcoholic beverages coming from her breath. Her eyes were glassy and bloodshot. She said she had a couple of beers and a shot. She slurred some of her words as she spoke. She performed 1 field sobriety exercises and showed impairment. She refused to complete the additional FSE's. Her breath alcohol content was .160 / .164.
