

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 5/20/21 the defendant entered the Wal Mart Market store and removed items from the shelves. She then fraudulently returned some of the items and departed the store without rendering payment for other items.
 On 5/23/21, the defendant entered the same Wal Mart Market store and placed several grocery items in a shopping cart. She checked out using the self-checkout lane. The defendant skip swiped some items and used other, cheaper items, to swipe for more expensive items.
 The total value of the items the defendant defrauded the victim of was \$100. The defendant fled from the area of the incidents, on both occasions, in a gold Chrysler Sebring bearing FL tag Z918KF.
 Both incidents were captured on surveillance video. The registered owner of the Chrysler Sebring (witness, Eloise McMorrow) positively identified the defendant as the person she lent her vehicle to and the person in both of the surveillance video footages. Her identity was confirmed via DAVID #M465-005-86-724-0.
 The defendant is the girlfriend of Eloise McMorrow's son and has been known personally by her for over a year.
