female half of the domestic. The caller advised there was an active domestic incident occurring at the address and firearms are known to be present.

Myself and Officer D. Esposito ID#: 985 arrived and made contact with the female half inside the apartment. The female half, white female, Aubrey I Fernandez (10/06/1994) stated that her husband white male, Christopher B Fernandez (01/19/1992) had just left and she was alone. Aubrey began to tell me that around 0845 hrs she noticed a picture of a female's genitals on Christopher's apple watch. (I would later read Aubrey her Miranda warnings and she made the following statement's) Aubrey stated she woke up Christopher who was sleeping in the bed inside the bedroom that they shared. Aubrey stated she open palm slapped Christopher in his hip area, and said to him "Get up you cheating motherfucker". Aubrey explained to Christopher that she found communication between Christopher and another woman on his apple watch. Aubrey advised she ran to the bathroom with the watch and Christopher followed her.

Aubrey stated that Christopher tried to grab the watch from her and she pulled away. Aubrey stated that Christopher grabbed her by her throat, pressed her up against the bathroom wall and started to squeeze her throat. Aubrey advised it was a long enough duration from the time he started squeezing that she was gasping for air. Aubrey stated that she dropped the watch and that Christopher let go off her throat. Christopher exited the bathroom. Aubrey stated she then to the spare bedroom with her cell phone and began calling her job to let them know she would not be in today. Aubrey then called her mother Christine M Ketterle (08/20/1973), and Ketterle called the police.

Aubrey then stated Christopher followed her a short time after. Aubrey advised Christopher punched the door that leads into the bedroom out of anger. Christopher and began yelling at her and she tried to leave the spare bedroom by pushing passed Christopher. Both got into a struggle, pushing each other back and forth. Both separated and and Aubrey again went into their shared bedroom. Christopher apparently broke a picture frame which was shattered into pieces on the floor. Aubrey advised she was upset about the picture frame being broken.

Aubrey stated Christopher started to beat himself in the head with the broken picture frame. Aubrey stated she was across the room when Christopher threw the piece of picture frame at a her, striking her in the left side of her head.


Aubrey advised that she went to the floor in pain and Christopher came over to her. Aubrey then got up from the floor and stated Christopher started to yell at her to hit him. Aubrey advised she open palm slapped Christopher in the face. Aubrey told Christopher to leave because the police had been called and that "Really fucked up". Christopher then left the scene in a black Chevrolet Impala 4D.

While on scene with Aubrey, obtaining her statement, Christopher returned to the scene and was speaking with Fetterle. Both were approximately 100 yards south west of the apartment sitting at a picnic table. I made contact with Christopher at the picnic table. Christopher advised he had a firearm on his person. Christopher was detained in handcuff's for safety while I retrieved his belongings from his pockets and secured a .38 caliber firearm from his inner belt loop. Christopher was cooperative and was later taken out of handcuff's and placed into the rear of my marked patrol car.


Christopher was read his Miranda Warnings and I questioned him as to his involvement. Christopher stated that he was awakened this morning by Aubrey who was slapping his face with a open palm, at least six different

times. Christopher then stated that he followed Aubrey into the shared bathroom and grabbed her arm until she let go of the apple watch. Christopher advised Aubrey then ran into the spare bedroom and Christopher followed her. A verbal argument ensued between both and subsequently a shoving and pushing match until they separated.

Aubrey went back into the shared bedroom followed by Christopher. Christopher stated that he was then struck by Aubrey on the left side of his neck with a piece of the broken picture frame that he admitted to slapping to the floor. Christopher advised Aubrey slapped him with an open palm strike to the left side of his face. Christopher stated he left and went to the Boynton Inlet to let the situation die down. Christopher returned and was met by police.

Christopher had a inch and a half visible cut on the left side of his neck. Aubrey had nickel abrasions on her collar bone and a quarter sized lump on the left side of her head. Minor injuries to report. I could not see any more injuries. I took photographs of both subjects injuries.

I find probable cause to charge Aubrey with domestic battery and Christopher with domestic battery. Both subjects were lodged in the Palm Beach County Jail for their respective charges.
