I was on routine patrol near the 6000 Block of Hypoluxo Rd in unincorporated Lake Worth, Palm Beach County. As I was traveling westbound on Hypoluxo Rd, I observed a silver Mercedes in the left turn lane near the Via Bari community. As I was about to pass the Mercedes is abruptly cut over into my lane, nearly causing me to collide with it. I had to quickly brake in over to avoid the collision.

As the vehicle continued to travel westbound on Hypoluxo Rd in front of me (left lane), I observed that it repeatedly failed to maintain its' lane; at times drifting well over a foot into adjacent center lane. On several occasions, the vehicle traffic in that center lane had to brake in order to avoid a collision. The Mercedes had Florida tag JYFH63 and was operated by a female driver. As we continued westbound, the vehicle continued the above referenced driving pattern several more times. Based on that I conducted a traffic stop on the vehicle for failure to yield to my right of way (cutting over in front of me) and to also check on the health and welfare of the driver due to the observed driving pattern. I activated my lights/siren to conduct the stop on the vehicle.

The driver pulled over into the left turn lane just east of Hypoluxo Rd. I made contact with the driver who was identified via her Florida DL as Ms. Aurora Leon (DL# L500-009-62-674-0). I instructed her as to the reason for the stop and she replied back that she didn't know where she was. She indicated that she lived in Boynton yet didn't know where she was going, even though we were in unincorporated Boynton Beach/Lake Worth area. As she spoke to me I could smell the strong odor of an unknown alcoholic beverage coming from her breath/mouth area. So much so that it was strong and distinct though the mask I was wearing. Her speech was heavily slurred, her eyes were bloodshot/water, and her responses were incoherent at times. She seemed to mumble as she spoke to me and kept repeating herself. I asked where she was coming from/going to, to which she replied that she was coming from a work lunch. She admitted to having one, then "two" drinks as she held up one finger. Her mannerisms were labored and lethargic, her muscle tone was flaccid and her eyelids appeared droopy.

Based on the driving pattern and numerous indicators of impairment, I requested a DUI unit respond to the scene to further assess Ms. Leon. The investigation was turned over to Investigator Soloway #8586.



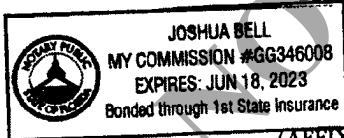

PERSONAL CONTACT

I responded to assist DS R Dalton #32421 with a possible impaired driver. Upon my arrival he advised me:

On 7/2/2020 at approximately 17:27 hours I was on routine patrol near the 6000 Block of Hypoluxo Rd in unincorporated Lake Worth, Palm Beach County. As I was traveling westbound on Hypoluxo Rd, I observed a silver Mercedes in the left turn lane near the Via Bari community. As I was about to pass the Mercedes is abruptly cut over into my lane, nearly causing me to collide with it. I had to quickly brake in over to avoid the collision.

As the vehicle continued to travel westbound on Hypoluxo Rd in front of me (left lane), I observed that it repeatedly failed to maintain its lane; at times drifting well over a foot into adjacent center lane. On several occasions, the vehicle traffic in that center lane had to brake in order to avoid a collision. The Mercedes had Florida tag JYFH63 and was operated by a female driver. As we continued westbound, the vehicle continued the above referenced driving pattern several more times. OBSERVATION OF DRIVER:

Upon my arrival the defendant was sitting in the driver's seat of her vehicle and was on her cell phone. I requested she exit her vehicle and she ignored me. I request she exit the vehicle several more time but she refused. I then ordered her out of the vehicle and she complied but held onto her phone. I asked her to put it down and she refused. I then took her phone from her and placed it into her vehicle. Her speech was slurred and her eyes were red and glassy. The defendant had an odor of an unknown alcoholic beverage on her breath which was apparent as she spoke. She was defiant in cooperating with my questions and investigation. At the BAT, she displayed significant mood swings. She went from being friendly and chatty to yelling at me and banging on the holding cell door.

DRIVER'S STATEMENTS:

The defendant refused to perform roadside tasks. As I attempted to explain the repercussions, she continually said "no". I explained that if she failed to comply with my request to perform roadside tasks, it could be used against her in court. I also explained that I would be forced to conclude my investigation and base my decision as to her impairment solely on the facts at hand. She again refused to submit to the tasks.

The defendant had an odor of an unknown alcoholic beverage on her breath.

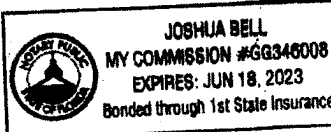

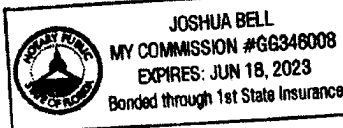
