The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 04 day of DECEMBER, 2019,

at approximately 1:05 AM, at 3655 HOSPITALITY LN, in Pinellas County did:

WAS THEN AND THERE INTOXICATED AND CAUSED A PUBLIC DISTURBANCE, TO-WIT: DEFENDANT WAS CONSUMING ALCOHOLIC BEVERAGES IN A PUBLIC AREA AND WAS CAUSING LOUD AND RAUCOUS NOISE AT AN UNREASONABLE HOUR.

THE DEFENDANT WAS CONSUMING ALCOHOLIC BEVERAGES AND CAUSING LOUD AND RAUCOUS NOISE OUTSIDE OF HOTEL ROOMS IN THE BREEZEWAY. HOTEL STAFF RECEIVED MULTIPLE COMPLAINTS FROM CUSTOMERS REGARDING THE DISTURBANCE CAUSED BY THE DEFENDANT. THE DEFENDANT WAS ASKED MULTIPLE TIMES BY HOTEL STAFF TO STOP THE RACIOUS NOISE/PARTY. THE DEFENDANT AND THE GROUP OF PEOPLE HE WAS WITH CONFRONTED ONE OF THE SUBJECTS WHO COMPLAINED AND NEARLY STARTED A PHYSICAL BRAWL. UPON ARRIVAL, YOUR AFFIANT HEAD LOUD VOICES FROM APPROXIMATELY 150 FEET AWAY. YOUR AFFIANT OBSERVED THE DEFENDANT ATTEMPT TO CONCEAL OPEN CONTAINERS OF ALCOHOLIC BEVERAGES UPON SEEING LAW ENFORCEMENT. THE DEFENDANT ATTEMPTED TO LEAVE THE SCENE AND FLEE UPON SEEING LAW ENFORCEMENT. YOUR AFFIANT COULD DETECT THE STRONG SMELL OF ALCOHOLIC BEVERAGES WHEN THE DEFENDANT SPOKE.

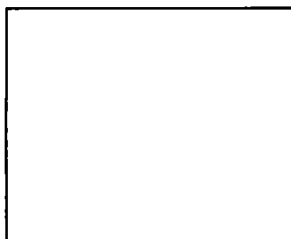
