The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On 10/24/2020 at 0242 hours I conducted a traffic stop on a blue 2017 Nissan Sentra sedan after I observed the vehicle drifting from side to side and then sit at a traffic light after it turned green(Azeele St W and Armenia Av S). I then ran the tag and discovered that it expired on 09/30/2020. Suspecting that the driver was ill, fatigued, or impaired, I conducted a traffic stop as the vehicle proceeded northbound on Howard Av N at Kennedy Bl W during a yellow traffic light. Upon contact with the driver of the vehicle, defendant Bailey McKay Johnson, I observed that she had bloodshot glassy eyes and then as I explained to her why I had stopped her I detected a distinct odor of an alcoholic beverage. The defendant then "declined" to perform the SFSEs. At which time I placed her under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0248 hours. I then transported the defendant to the HCSO/CBT Facility where she refused to submit to a breath test. Implied Consent was read at 0351 hours. I identified the defendant with a valid FL DL. She was the only one in the vehicle.
