On the **11** day of **July**, **2020** at **10:26** (Specifically include facts constituting cause for arrest.)

On 06/14/20 I was dispatched to a teleserve call of an assault that occurred at 5500 North Military Trail. I contacted complainant Peter Vapnek via landline who reported his ex-wife, Bari Vapnek has been sending inappropriate messages. Bari was contacted via landline and was told that Peter did not wish to receive any personal or inappropriate messages on the court approved App (Zell). Bari was told that the App was to be used to exchange money for support and alimony. It was not to be used for Bari to send messages about Peter's relationship with his girlfriend. Bari stated that she understood and would no longer send messages to Peter other than to exchange money. Bari was informed that Peter did not want her to contact him on Facebook or on any other social media. Bari said she understood what the court approved App was for and would no longer write messages about Peter's relationships or other personal issues.

On 07/10/20 Peter contacted this Officer and explained that Bari has continued to email and use the court approved App for inappropriate purposes. Peter stated that Bari has sent approximately fifty malicious messages on the court approved App and Peter's email. On 07/11/20 I met with Peter and obtained copies of the court approved App messages, Twitter messages, and emails Bari sent him without his permission. Some of the messages from 06/20/20 through 07/01/20 read "You can afford a hotel room for two days but can't pay my rent"; "Your enjoying that sexy body in the sun you need to give me money"; "Does the rape victim watch or just listen." There were hundreds of messages. Peter completed a sworn statement that was captured on MVR. The statement was marked and submitted into evidence. Bari engaged in a course of conduct to communicate words through the use of electronic communication directed at Peter thereby causing Peter emotional distress to Peter. The communications served no legitimate purpose. The case has been filed with the Florida State Attorney's Office charging Bari with Cyber Stalking (Florida State Statute 784.048 (d) (1)).
