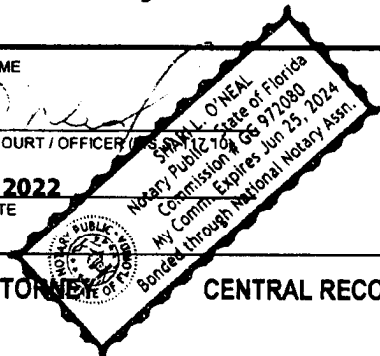

On 03/05/2022 at approximately 0205 hours, this Officer was on patrol in the area east of PGA Blvd and Fairchild Gardens Av, PBG, FL, when a vehicle was observed traveling west bound in the outside through lane at an increased rate of speed. Body worn camera and in car video were activated upon traffic stop.									
This Officer visually esimated at approximately 55 MPH in a posted 45 MPH zone. Using RADAR Stalker DSR2X (DB001317), front antenna (KC086606) this Officer received a steady tone and reading of 58 MPH. The RADAR calibration was last checked on 11/19/2021 and was due on 05/19/2022. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. This Officer also observed the vehicle drift over the striped line twice then also almost half a vehicle width over the solid white fog line into the bicycle lane. This all occurred in the area between approximately Campus Dr and Lake Victoria Gardens Av, along PGA Blvd.									
This Officer attempted to stop the vehicle, a Toyota utility (CMBA13/FL) prior to entering the Interstate 95 south bound on ramp from west bound PGA Blvd. The vehicle decreased speed then continued along, despite this Officer activating audible sirens as well. The vehicle eventually slow rolled to a stop on the left-side should of Interstate 95, just south of PGA Blvd, PBG, FL. This Officer made contact with the driver and lone occupant, identified via Florida Driver License photo, Beata White (OF) while she was still in actual physical control of same. White had a flushed red face almost to the extent of sweating, glassy watery eyes, low slurred speech, and the moderate obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance. White said she just left work at "Angry Moon" and denied consuming alcohol on this night.

Based on this Officers observations, White was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which she complied. White said she did not have any medical conditions which would affect the exercises performed. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Streamlight Stylus. This Officer observed lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation, as well as the onset of Nystagmus prior to 45 degrees in both eyes. White also had vertical gaze Nystagmus in both eyes, twice. The next exercise conducted, was the Walk and Turn. The line used was a strip of yellow tape placed upon the pavement by this Officer. During the instructions, White kept stepping out of the starting position and had to be told to get back into proper position. White also started the exercise prior to being told to do so. Prior to starting the exercise, this Officer gave White the chance to take off her footwear and also ensured she understood instructions. During the first attempt, White missed heel-to-toe on each step. White took eight steps rather than nine, then conducted an improper turnaround, by way of spinning around. During the return set of steps, White missed heel-to-toe on each step and stepped off the line twice. During both sets of steps, White kept her arms raised from her sides. The final exercise conducted, was the One-Leg Stand. White raised her right foot. White swayed and again kept her arms raised from her sides. Based on this Officers observations, White was placed under arrest at 0320 hours. At PBSO BAT, this Officer requested White to provide a breath sample for the purpose of determining its alcohol content, to which she refused. This Officer read Florida Implied Consent to White, to which she acknowledged and again refused at 0320 hours. Post-Miranda warnings, White admitted to drinking Vodka on "Friday Night". It should be noted, this Officer arrested White for driving under the influence on 07/07/2020. Based on the results of the investigation, this Officer has probable cause to prove Beata White operated a motor vehicle, in the state of Florida, while under the influence to the extent her normal faculties were impaired, in violation of FSS 316.193(1) (A).

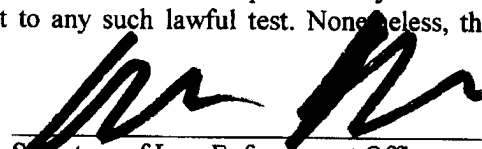

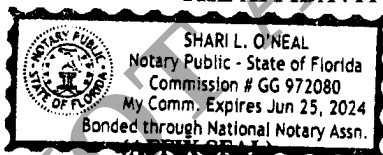

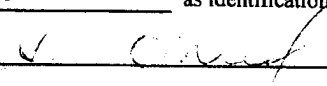
