The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/24/2019, at approximately 0326 hours, at Causeway Bl / Brandon Town Center Dr, Brandon, FL 33511, I conducted a traffic stop on a 2011 gray Ford Fusion (IDRP79 / VIN: 3FAHP0HA5BR254811) for speeding (warning issued) and an expired tag (UTC# ICRTPYE). Upon making contact with the driver, I observed her to have bloodshot watery eyes, slurred speech, and a severe odor of an alcoholic beverage on her breath. Based on these indicators, I requested for her to submit to field sobriety exercises, which she agreed to perform. During the exercises, further indicators of impairment were observed and the driver was subsequently arrested for DUI. While at CBT, the Implied Consent Warning was read to the defendant, at which time she stated she understood and refused to provide breath samples by stating, "No" when asked. The defendant was positively identified via her DAVID photograph.
