Ms. Stanhope stated that she was tired and just got off work heading home. West Palm Beach Fire Rescue wanted to check her vitals to make sure she was not having a medical condition. West Palm Beach Fire Rescue checked her blood sugar and blood pressure and advised she is clear of having any medical concerns. 
