DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On Saturday, June 13, 2020 at 22:03hrs, I, Officer Cameron Carver, was dispatched to US Highway 1 and PGA Boulevard, in the City of Palm Beach Gardens in Palm Beach County, Florida, in reference to a motor vehicle crash. My department issued body worn camera was activated and subsequently uploaded and tagged accordingly. Officer Redding #466 and Officer Morea #517 arrived on scene and assisted in securing the crash scene. Upon arrival I began my crash investigation and observed a gray Toyota Tacoma bearing Florida license plate Y45VYL, driven by Blaine Michael Hatton (identified via his Florida Driver's License), in the southbound left-through lane of US Highway 1. Hatton had rear-ended a gray Chevrolet Silverado bearing Florida license plate STD68, driven by Christopher Kinder (identified via his Florida Driver's License); who as a result rear-ended a red Toyota Rav4 bearing Florida license plate IK43NB, driven by Johille Bien-Aime (identified via his Florida Driver's License).

OBSERVATION OF DRIVER:

Hatton participated in the crash investigation. While interacting with Hatton I detected the odor of unknown alcoholic beverage emanating from his breath. Hatton's speech was slow, slurred and methodical. Hatton's eyes were bloodshot and glassy.

DRIVER'S STATEMENTS:

Post-Miranda, Hatton stated he was coming from a party in Jupiter/Tequesta at his friend's house. Hatton stated he started to drink at 14:00hrs on 06/13/20 and ended at 18:00hrs; drinking four (4) Michelob Ultra beers. Hatton stated he is on the "Keto Diet" and ate only cheese and meats. Hatton stated he 'grazed' with the food while drinking water. Hatton advised he did not have any issues with walking or maintaining balance; has no medical conditions that he takes prescriptions for; however, does have prescription glasses. Post-arrest, Hatton commented multiple times that he didn't want to go out this evening.

Odor of unknown alcoholic beverage.



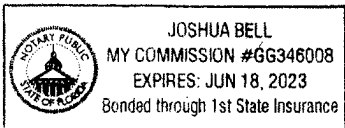

The instructions were explained and demonstrated to Hatton. During the instructional phase, Hatton was unable to keep balance and stepped out of position. Hatton started prior to being directed to. After instructions and Hatton stating he understood, Hatton started on command. Hatton missed heel-to-toe on step 1. Hatton took the correct number of steps, completing 9 steps. Hatton did not turn as instructed and demonstrated and raised his arms more than six inches. On the return, Hatton missed heel-to-toe on step 4. Hatton took the correct number of steps, completing 9 steps.

ONE LEG STAND:

The instructions were explained and demonstrated to Hatton, who stated he understood. During the instructional phase, Hatton was unable to keep balance and swaying. Hatton started prior to being told to do so. Upon the command to begin, Hatton again swayed while balancing and did not have his legs in the proper position, as well raised his arms out. I stopped Hatton and clarified for him the instructions and had him begin again. In the second run, Hatton raised his arms more than six inches to maintain balance and again swayed while completing the task.

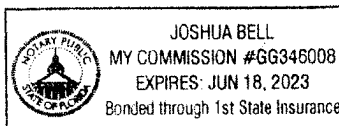
