The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the above listed date and time at the above listed location, Deputy Towne #257658, was dispatched to a traffic crash call for service. Upon her arrival, she observed two vehicles, a black Honda Accord bearing Florida tag: NPWC62, and a silver Ford Mustang bearing Florida tag: QBZY43 crashed in the middle of the road (See HCSO case# 20-827756, DHSMV #89438676). The damage was approximately \$30,000 dollars. Deputy Towne made contact with the defendant and observed signs of impairment. I arrived at the scene, made contact with the defendant, and observed signs of impairment. I requested the defendant to perform Standard Field Sobriety Exercises (SFSEs) which the defendant refused to perform. Based on the totality of the circumstances, the defendant was placed under arrest for DUI. The Victim of the Ford Mustang, Katelyn Rooblal, Identified the defendant as the person who was driving the black Honda Accord. Upon arrival at Central Breath Testing, the defendant refused to provide two lawful breath samples to determine his breath alcohol content (BrAC). I read Implied Consent to the defendant in room #1 of Central Breath Testing, he understood and replied "I'm not blowing". The defendant received a DUI citation #AE94SEE, which reflects the DUI charge. The defendant was identified via his Florida Driver's License.
