PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On 08/24/2021, I responded to the intersection of Belvedere Rd/ N Cleary Rd, Unincorporated West Palm Beach, FL 33413, in reference to Spanish translation for a crash involving a possible drunk driver.

Upon my arrival, I met with driver Blanca Villatoro Cabrera DOB: 07/20/1994 who was identified via foreign passport. While Blanca was given her verbal statement about the crash, I smelled the odor of alcohol and I observed that her eyes were bloodshot and glassy. Blanca stated that she was traveling northbound on N Cleary Rd and she was following behind a trailer truck that stopped in the stop sign at the intersection mentioned above. After the trailer turned Westbound on Belvedere Rd, she said that there is a nine seconds rule that after the vehicle in front of you passes the stop sign then you can cross the intersection after nine seconds. She said that the cars approaching the intersection needed to slow down for her because she has the right-of-way. Based on my investigation, DUI Investigator Tejada #31814 responded to the scene to assist with the DUI investigation.

OBSERVATION OF DRIVER:

Upon making contact with the defendant who was standing up behind her vehicle, leaning up on the trunk. I immediately smelled an obvious odor of an unknown alcoholic beverage coming from the defendant's breath, which intensified as she spoke with me. I observed the defendant's eyes to be glassy and blood shot. I also observed the defendant to have a slow and slurred speech. The defendant was asked to step in front of my patrol car to speak with me, as she stepped towards my car she staggered to the side and had an unstable balance. I also observed the defendant to have a sway as she stood normally without walking.

DRIVER'S STATEMENTS:

The defendant stated she was on the way to drop off a coworker from work. She stated she was driving her 2019 Nissan Sentra. She stated she has no medical conditions. She stated she is not currently taking any medications. She stated she has not hit her head recently. She stated she has no physical defects or injuries. She stated she was a cashier and last worked today. She stated she did not know what street she was driving on or what direction of travel she was going. She stated she has not smoked any marijuana or taken any illegal drugs. She stated she drank 2 Bud Light beer bottles, the 1st beer at around 500PM and the last one around 630PM. She stated it was approximately 9 something PM it was actually 1141PM. She also stated today's date was July 24, 2022.

ODORS:

An obvious odor of an unknown alcoholic beverage coming from her breath which intensified as she spoke with me.

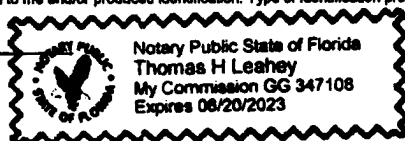

Other Observations:

The defendant was placed into the instructional stance for the Horizontal Gaze Nystagmus. She failed to maintain the instructional stance by separating her feet to help steady herself. She verbally identified the blue stimulus that I was holding up. I checked her eyes for equal pupil size, equal tracking, and resting nystagmus. She failed to follow the stimulus with her eyes only and was reminded several times not to move her head. She swayed from side to side. I did not observe vertical nystagmus.

WALK & TURN:

I explained and demonstrated the instructions for the "Walk & Turn" to her. She stated she understood the instructions and had no questions for me. She began the task too soon, without being told to do so. She failed to maintain the instructional stance by separating her feet to help steady herself. She took the incorrect number of steps. She did not count as instructed. She improperly turned around. She used her arms for balance. She stepped off the line several times.

ONE LEG STAND:

I explained and demonstrated the instructions for the "One Leg Stand" to her. She stated she understood the instructions and had no questions for me. She failed to maintain the instructional stance by separating her feet to help steady herself. She used her arms for balance. She did not look at her feet as instructed. She swayed from side to side and front to rear. She put her foot down prior to the 30 seconds elapsing.

FINGER TO NOSE:

I explained and demonstrated the instructions for the "Finger to Nose" task to her. She stated she understood the instructions and had no questions for me. She failed to touch the tip of her finger to the tip of her nose as instructed. She did not touch the tip of her nose on each of the attempts. She used the pad of her finger on each attempt. She did not keep her head tilted backwards as instructed. She did not keep her eyes closed as instructed.

RHOMBERG ALPHABET:

I explained and demonstrated the instructions for the "Rhombert Alphabet" task to her. She stated she understood the instructions and had no questions for me. She failed to maintain the instructional stance by separating her feet and was reminded to keep her feet together. She did not keep her eyes closed as instructed. She improperly recited the Spanish Alphabet.

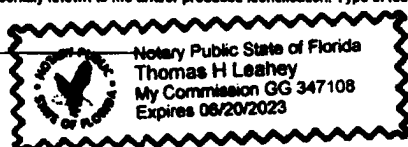
