The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 On the listed date and time at the above listed location, Deputy Perez #254523, observed a red Honda CRV bearing Vermont tag: HXA647, traveling southbound in the northbound lane on Dale Mabry. Deputy Perez conducted a traffic stop on the listed vehicle. Deputy Perez advised me, before making contact with the defendant, the defendant attempted to switched places with the passenger. Upon making contact with the defendant, Deputy Perez observed signs of impairment. Upon making contact with the defendant, I observed multiple signs of impairment. I requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. It should be noted, when asked the defendant for her identification card, the defendant provided me with an Illinois (N342-069908897) driver's License where later was determined was a counterfeit driver's License. I transported the defendant to a mobile breathalyzer. The defendant agreed to provide two lawful breath samples to determine her breath alcohol content (BrAC). After a proper 20 minute observation period was conducted, the defendant provided two lawful samples of her breath. First BrAC sample (.170): Second BrAC sample (.173) The defendant received a DUI citation #A30NFRE, which reflects the DUI charge. She also was charged with a Fictitious Counterfeit unlawful Driver's License 322.212 (1)(a). The defendant verbally identified herself which was confirmed via her Vermont Driver's License.
