THE DEFENDANT WAS DRIVING A WHITE CHEVROLET TAHOE BEARING FL TAG NUMBER KMTV03 REGISTERED TO HIS FATHER. THE DEFENDANT DID NOT HAVE PERMISSION TO UTILIZE THE VICTIM'S DEBIT CARD. THE NAME ON THE DEBIT CARD REFLECTED MARY DICKERSON NOT BRADLEY HOTZ. THE DEFENDANT KNEW AT THE TIME OF THE OFFENSE THAT THE DEBIT CARD DID NOT BELONG TO HIM.

THE DEFENDANT UTILIZED THE VICTIM'S DEBIT CARD AND PIN NUMBER ON 10/20/2019 AT 1117 HOURS AT ACHIEVA CREDIT UNION DRIVE-THRU ATM LOCATED AT 2201 DREW ST, CLEARWATER TO WITHDRAWAL \$200.00 IN CASH. THE DEFENDANT WAS DRIVING A WHITE CHEVROLET TAHOE.

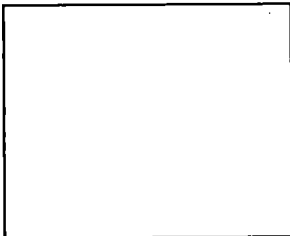
