On the 19 day of May, 2020 at 00:57 (Specifically include facts constituting cause for arrest.)

On 5/19/2020 at approximately 0057 hrs, I was requested by MPO Marinucci via radio to respond to the 1200 block of Town Center Drive, Town of Jupiter, in reference to assisting with an investigation. While en route, I heard MPO Marinucci advise that he needed backup urgently, at which time numerous units started en route to the call. Upon my arrival, I observed one male subject, Hunter Kempton (CO-DEFENDANT) on the sidewalk in handcuffs, and a second male subject, now identified as Bradley Emery (DEFENDANT), sitting in a chair further down on the sidewalk. I observed a grey Hyundai (VEHICLE-1), bearing FL tag EIC-G52, improperly parked facing east in the westbound lanes, obstructing traffic.

MPO Marinucci advised me that he observe Bradley behind the wheel of the vehicle. He advised that he observed Bradley and the other male attempt to talk to a female subject outside of the car. MPO Marinucci advised the situation escalated when the subjects were informed that they were not free to leave and they became verbally hostile. MPO Marinucci advised me that while speaking to Bradley about his investigation, he observed signs of possible impairment. He asked me to take over the investigation to determine whether or not Bradley was impaired.

I made contact with Emery, who was still sitting in the chair. I asked him to stand up and come talk to me. I observed that Emery, upon standing up, was unsteady on his feet. There was a very strong odor of unknown alcoholic beverage emitting from his person, which intensified as he spoke. He spoke with slurred speech. His eyes were glassy and bloodshot. I told Emery to lean against the wall as I spoke to him, as I was afraid he would lose balance and fall over. I asked Emery how much he had to drink and he stated "two beers". He advised he ate earlier. I asked him on a scale from 1-10 of impairment with 1 being completely sober and 10 being highly intoxicated where he would rate himself. He advised he was a 2. I asked him to participate in field sobriety exercises and he refused. I advised him of his Taylor warnings and gave him a chance to participate in field sobriety exercises again. Emery advised me that he would not




participate in field sobriety exercises.

Based on the totality of the circumstances and my investigation up to this point, I had probable cause to believe that Bradley Emery had been in actual physical control of a motor vehicle while under the influence of an alcoholic beverage, chemical or controlled substance, to the point where his normal faculties were impaired. I placed him under arrest at 0108 hrs. I transported Emery to the Palm Beach County BAT, arriving at 0137 hrs. I placed Emery under the 20 minute observation period, during which I did not observe him consume nor regurgitate anything. We then went on video with BAT Technician Pound (ID #24639). I requested a breath sample from Emery and he asked me what would happen if he refused. I read him implied consent from a pre-prepared sheet, minus any CDL language, and he made sure he understood. He then consented to providing breath. The first sample given gave a purge error. Another ten minutes was given to let the instrument clear.

During these tenminutes, I again did not observe Emery consume nor regurgitate anything. Emery then provided valid samples of breath, reading at .234 BrAC and .254 BrAC. I read Emery his Miranda rights and he stated he understood. Upon questioning he now advised he had three beers earlier. He did not think that he was impaired. I then placed Emery in a holding cell while I completed my paperwork. I then booked him into the Palm Beach County jail on one count of DUI with enhanced BrAC. I issued him a court date of 7/1/2020 at 0830 hrs at North County Courthouse. I additionally issued Emery a citation for his parking offense. His vehicle was towed from the scene by East Coast Towing. BWC.

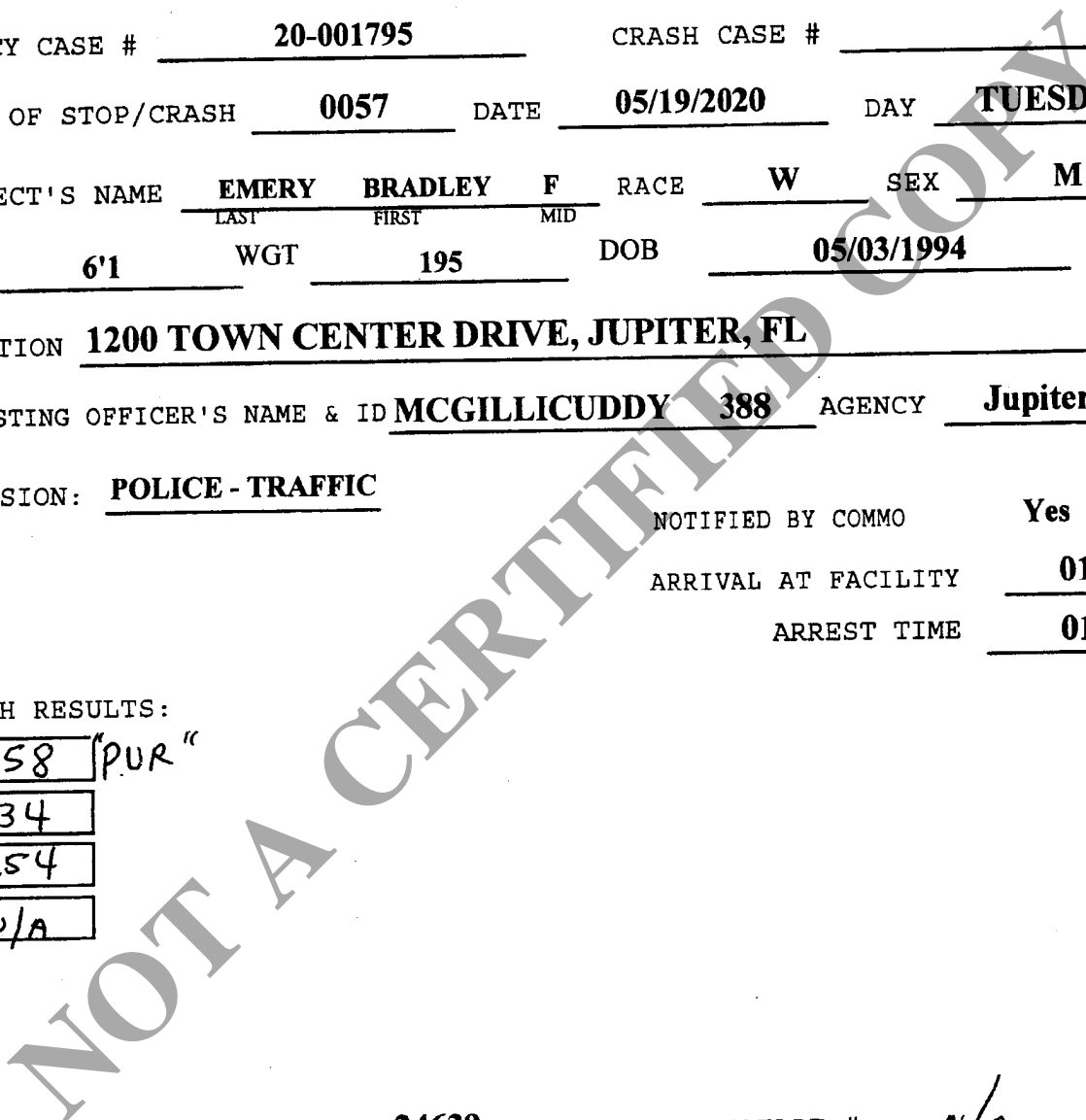
