AT THAT TIME, I COULD SMELL THE IMPURITIES OF AN ALCOHOLIC BEVERAGE ON HIS BREATHE, GLASSY/WATERY EYES AND HIS SPEECH WAS SLURRED. AT THAT TIME JACKSON WAS PLACED UNDER ARREST.
