Carmack #323 who conducted a traffic stop on a wrong way driver. Cpl. Carmack advised the defendant was operating the vehicle and in actual physical control at the time of the stop. Cpl. Carmack also observed the defendant to be showing signs of impairment. The defendant's identity was confirmed via DAVID photograph. The defendant was advised of the criminal DUI investigation and asked if she would be willing to complete FSE's. The defendant agreed and the FSE were administered. The defendant unsatisfactorily completed the FSE's and was placed under arrest for DUI. The defendant was transported to CBT where the DUI investigation was continued. The defendant initially refused to provide a sample of her breath and was read Implied Consent. Post implied consent, the defendant agreed to provide a breath sample. The defendant provided breath samples of .209 .208 at 0524 and 0528 respectively. An ECRA was completed charging the defendant with DUI BAC over .15.
