The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did Officer's Lehr and Przeporia observed the defendant driving a Ford pick up truck with FL tag LXWH19 on the roadway. He was weaving side to side and speeding 50 MPH in a 30 MPH zone. When he turned on Sterling Ave to pull over he ran over the raised curb. Upon contact with the defendant they observed signs of impairment and requested a DUI officer to respond. I made contact with the defendant who was in the driver's seat. I could smell the odor of alcoholic beverages from his breath. His eyes were glassy and bloodshot. He was slurring his words and when he was out of the truck he was unsteady on his feet. He was unable to answer simple questions appropriately and refused to do field sobriety exercises.

I went to place him under arrest for DUI and told him to turn around and face away from me and I took hold of his arm to place the handcuffs on him. When he turned he tried to pull away and run from me. I kept hold of his arms and he turned to me and pushed me in the chest to try to get away from me. Officer's Przeporia and Lehr came to assist and grabbed hold of him so I could put the handcuffs on. All three officers on scene were in full uniform with 2 marked Tampa Pplice Vehicles with emergency lights on.

Post arrest I advised him of implied consent and he understood and refused to provide a breath sample.
