 On 01/29/2020, at approximatley 0107 hours, near the intersection of 56th Street North and Sligh Avenue East, Tampa, Florida 33617 Deputy G. Absolu ABN: 260361 observed the defendant/driver operating a grey 2019 Hyundai Kona bearing Florida tag QDDS25 with an assigned VIN of KM8K12AA3KU212648 in the wrong lane and obstructing the general flow of traffic. Upon Deputy Absolu's contact with the defendant, he observed multiple indicators of impairment. Upon the affiant's contact with the defendant, I observed him to have bloodshot/watery glassy eyes, he was unsteady on his feet, slurred speech, and I smelled the strong odor of an alcoholic beverage emitting from his breath. The defendant participated in field sobriety exercises and while doing so, he demonstrated further indicators of impairment. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration, the defendant was placed under arrest for DUI. The defendant was transported to Central Breath Testing and he provided two lawful breath samples of .195 and .199. The defendant identified himself verbally. I further identified the defendant via his DAVID photograph.
