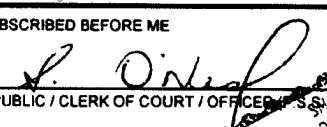

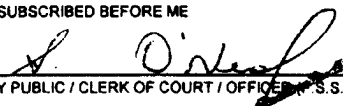
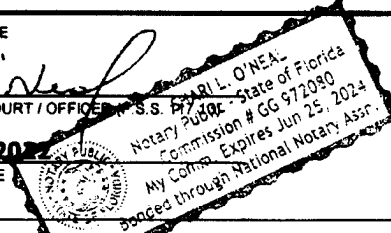

On the <u>14</u> day of <u>April</u>, <u>2022</u> at <u>23:40</u> (Specifically include facts constituting cause for arrest.) On 04/14/2022 at approximately 2340 hours, this Officer was conducting speed measurement enforcement in the area of the 12300-block of Central Blvd, PBG, FL, when a vehicle was observed traveling at an increased rate of speed south bound in the inside through lane. Body worn camera and in car video were used in the investigation. This Officer's initial visual estimation of the vehicle, was 55 MPH in a posted 45 MPH zone. Using RADAR Stalker DSR2X (DB001317), rear antenna (KR027120) this Officer received a steady tone and reading of 57 MPH. The RADAR calibration was last checked on 11/19/2021 and was due on 05/19/2022. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. As the vehicle, a Jeep utility vehicle (KSBUS0/FL) passed, this Officer observed the vehicle to not have any rear lights activated at all. This Officer entered the lane behind the vehicle and attempted a traffic stop by activating overhead red and blue lights, in the area of 117th Ln N. The vehicle continued south bound and then activated its left-hand turn signal. The vehicle then turned off the turn signal and eventually pulled over on the right-hand side of the road. This Officer approached the vehicle on the driver side and made contact with the driver, identified via Florida Driver License photo, Brandy Kraker (OF), while she was still in actual physical control of same. Kraker had bloodshot watery eyes, flushed red face, slur in her speech and the obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance. Kraker said she was coming from a "tennis party" at Old Marsh and admitted to consuming two glasses of wine. Based on this Officers observations, Kraker was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which she complied. As Kraker approached

the rear of the vehicle, she did stumble one time. Kraker said she did not have any medical conditions which would affect the exercises performed. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Toxoptix X3 with an illuminated red light. This Officer observed lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation, as well as the onset of Nystagmus prior to 45 degrees in both eyes. Kraker also had Vertical Gaze Nystagmus in both eyes. The second exercise conducted, was the Walk and Turn. The line used was a strip of yellow tape placed upon the pavement by this Officer. During the first set of steps, Kraker raised her arms more than six inches from her sides. Kraker conducted an improper turnaround by way of removing her planted foot from the line. During the return set of steps, Kraker again raised her arms more than six inches from her sides. Kraker took eight steps, but counted nine. The final exercise conducted, was the One-Leg Stand. During the exercise, Kraker raised her right foot. Kraker lost her balance, swayed, raised her arms more than six inches from her sides and placed her foot down. Kraker also had difficulty counting, she repeated eleven. Based on this Officers observations, Kraker was placed under arrest at 2356 hours. During a tow inventory of the vehicle, contraband was discovered. In the center cup holder, this Officer located a clear glass containing a light color liquid with the odor of an unknown alcoholic beverage. A purse was located on the front passenger seat, which had Krakers wallet located within. Also in the purse was a white plastic container labeled "Advil". Inside the container a blue Advil gell capsule was located as well as a peach oval shaped pill which was stamped "e 506" and "3 0", which was split in half. Upon further investigation this Officer determined the pill to be Amphetamine and Dextroamphetamine 30 mg. Ofc Luscavich 513 advised Kraker of her Miranda Warnings to which she said she understood. This Officer asked Kraker about the pill to which she said it was a friends she was holding onto from a trip to Nashville. Kraker said the friend had the prescription for the pill. At PBSO BAT, this Officer requested Kraker to provide a breath sample for the purpose of determining its alcohol content, to which she refused. This Officer read Florida Implied Consent to Kraker to which she acknowledged and again refused at 0052 hours. Based on the results of the investigation, this Officer has probable cause to prove Brandy Kraker operated a motor vehicle, in the state of Florida, while under the influence to the extent her normal faculties were impaired, in violation of FSS 316.193(1)(A). Kraker was also in possession of a controlled substance without a prescription, in violation of FSS 893.13(6)(A).

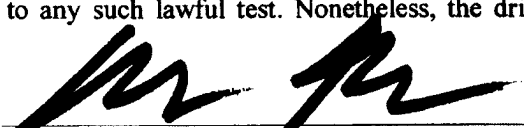

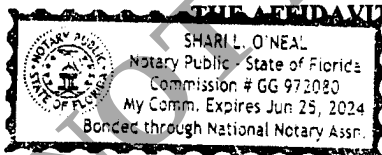

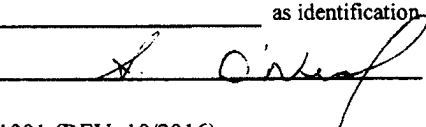
