 On above listed date and time at listed location a traffic stop was conducted on a gray Hyundai bearing FL tag #GLED14 for driving without headlights on. Contact was made with defendant who was the driver of the vehicle. The defendant had watery glassy eyes and was trying to avoid looking at Co Affiant. Defendant also had slurred speech. Based on these observations, the defendant was requested to exit the vehicle where an open alcoholic beverage which was later found to be cold to the touch was in the driver door. The defendant was observed to be unsteady on her feet. The defendant was requested to completed Standardized Field Sobriety Exercises which she agreed to.
