<p>On 5/12/2021, at approximately 0253 hours, I was dispatched to 6061 Boca Colony Dr, unincorporated Boca Raton, Palm Beach County, Florida, in reference to a disturbance at the community pool.</p> <p>On arrival, I made contact with the complainant, Vinny Daddario, on the street, who stated that there were several people swimming and shouting in the pool at that hour, and they were disturbing the families and prevent them from sleep. Deputy Similien and I walked into the clubhouse pool area through the metal gate. The pool area was enclosed in a metal fence with posted signs stating the rules and hours of operation for the pool.</p> <p>As I approached the pool I observed approximately eight individuals in the pool shouting and screaming. Three subject had three others on their shoulders while playing around. I observed a white male (later identified as Brendan Michael King) in the pool, and Brendan had a large can of Bud Light Beer in his hand, and consumed the beverage. I asked Brendan what he had in the can and he stated "a beverage" I asked alcohol and Brendon said "yes".</p> <p>I asked all the subjects to exit the pool and provide their identification cards. Brendon exited the pool wearing no shirt and a pair of red shorts. I asked Brendon to place the can of Bud Light Beer on the table and provide his identification. Brendon walked around the pool area in circles, checking each area more than once. I asked Brendon what he was doing, and he stated that he was looking for his stuff. After several minutes Brendon located his clothes including his blue jean pants that had his wallet. Brendon put the wallet in his hand and covered it with the pants, then he stated that he did not have any ID. I instructed Brendon to open the wallet and removed his Identification as requested, which he did.</p> <p>While I was communicating with the other subjects about their identification and the legality of consuming alcohol in public, Brendon attempted to grab the ID from my hand. I quickly moved my hand so he missed. Brendon then made a second attempt at grabbing the ID from my hand; the second time he slapped my hand as he grabbed the ID. Brendon then began to run toward the metal gate fence that was attached to the concrete building. I ran after Brendon and attempted to hold him by placing my left arm around his upper torso as we approached the metal gate and concrete wall. Before the gate there was an area with small landscape hedges, and Brendon attempted to jump over the hedges while I held him, which caused him to trip over the hedges. I subsequently tripped and fell as Brendon slipped out of my grasp. Brendon got up and continued to run through the gate.</p>

<p>As I fell, I was close to the concrete wall corner, and my head was first in line to impact the corner of the concrete wall with the force of the fall. I immediately put my left arm out to cushion the blow and push off the wall in a different direction, but the momentum was greater and the right side of my face struck the concrete wall as I turned my head away from the edge of the wall. I sustained a small laceration on my face and swelling on the right side of my face. The muscles in my left arm were contracted and also had swelling, which restricted movement several minutes after the fall.</p> <p>During the fall Brendon dropped his wallet, mobile phone and clothes. After Brendon got through the gate he turned around to retrieve his belongings before his getaway. I secured Brendon's left arm and Deputy Similien secured Brendon's right arm, then held him against the fence. Brendon was placed under arrest. Brendon was handcuffed to the rear, checked for fit and double locked. Brendon was then placed in the back of my marked patrol vehicle. He later made an exited utterance indicating that he was very sorry about what he did because it was totally unprovoked.</p> <p>Based on my investigation, probable cause exists to charge Brendon Michael King, with one count of Battery on a Law Enforcement Officer pursuant to FSS 784.07(2B), Resisting Arrest without violence pursuant to FSS 843.02, and Unlawful Possession of Alcoholic Beverages Pursuant to FSS 843.02.</p>
