The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was operating a gray 2018 Toyota Tacoma pick up truck, Florida tag DMLZ13. The defendant drove in a manner in which the right side tires crossed onto, over, and straddled the outer painted lane marker multiple times. The defendant continued straight from a right turn only lane. The defendant drove at a speed of 40 MPH in a properly posted 30 MPH speed limit (visually estimated and patrol car unit 5153 paced). A traffic stop was initiated to in order to check on the driver's condition and determine if she were sick, tired, distracted, or impaired. During the traffic stop, the defendant stopped her vehicle hard and placed the vehicle into park while the vehicle was still in motion. The defendant had a distinct and strong odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot and watery, and her face was flushed. The defendant stated she drank 6 Lemon Drop shots over the past 12 hours. The defendant had difficulty multi-tasking as she never looked for requested documents after providing her driver license. The defendant swayed while standing, and had difficulty following simple instructions. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and was arrested for DUI. The defendant refused to submit to a lawful breath test after being read the Implied Consent Warnings. While in Central Breath Testing, the defendant vomited several times. The defendant was positively identified by her Florida DL.
