PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I was responding to 300 Ryder Cup Blvd, Palm Beach Gardens, FL 33410 in reference to a suspicious vehicle that was stopped at the gate. The white Cadillac Escalade bearing FL tag IZJP75 did not have a front left tire. While the caller was on the phone with police dispatch, the vehicle drove through the gate into the secured community. Roving Security Supervisor Kenneth Crumpton observed the vehicle northbound on Avenue of the Masters driving at a high rate of speed with the vehicle smoking. I was turning onto Avenue of the Masters from Avenue of the Champions and I observed the white Cadillac driving westbound in the eastbound lanes. Upon seeing me, the driver, later identified via his Florida Driver's License as Brian Cork, sped up and made a sharp turn, causing the Cadillac to spin around, gouging the roadway and leaving skid marks and make a 275 degree turn in an attempt to flee. I ordered Cork out of the vehicle and placed him into handcuffs for scene safety.

OBSERVATION OF DRIVER:

Cork had bloodshot, glassy eyes. He appeared confused/dazed and had a blank stare. Cork had the strong odor of an unknown alcoholic beverage coming from his person. Cork had difficulty with maintaining his balance and when un-handcuffed leaned on the patrol vehicle for balance. Cork's speech was slurred, and was confused as to where he was located (claiming he was in Martin County) or where he was coming from (Palm Beach County).

DRIVER'S STATEMENTS:

Cork stated he was coming from a "girls" place, but could not recall where. He believed he was in Martin County. Stated there was no damage to his vehicle, but that the damage to his vehicle is a problem. Did not want to perform SFST's, asking if he could walk home. Explained Taylor Warnings to Cork and he did not provide a definite answer, but kept "thinking." No medical conditions. Invoked Right to Council.
