On Saturday, August 28, 2021, at approximately 15:31 hours, I responded to the Jupiter Beach Resort, 5 N. A1A, Jupiter in reference to a call received via '911' about a "drunk guest" who tried to assault another guest in room 314. I arrived with Ofc. Levinstein (ID 358) and Ofc. Gundlach (ID 345) and we were directed to the third floor where they stated an intoxicated white male, wearing a plaid shirt, jeans and sneakers was "running around the third floor pulling on door handles."

Resort Security, Tuckeem Wright (b/m 07/21/1989) told us that the subject, (later identified by his NY drivers license as Brian C. Barrett w/m 02/03/1973), was involved in some sort of verbal altercation with another hotel guest at the bar on resort property. Barrett then followed that guest up to the guest's room #314 and attempted to push and shove the guest. According to Wright, the guest in room #314 did not want any further interaction with resort staff or police and advised he was leaving the resort.

We took the elevator to the third floor and were met by the Jupiter Beach Resort General Manager, Justin Earle (w/m 03/21/1983), resort security Brandon Burk (w/m 01/15/1985) and some other employees of the resort. We were directed to the left of the elevators where a subject matching the description was stumbling in the hallway, bumping into the walls and hotel room doors. Ofc. Levinstein made contact with the subject and began speaking with him as Ofc. Gundlach was with him. I spoke to a female employee who said "he's been drunk for a while now" and was on the third floor banging on doors trying to get into the wrong room. She further stated that he tried to fight the guest in room 314 and that the guest in that room did not want to speak with officers. Another employee, Burk, stated that he had received a complaint regarding Barrett earlier and had obtained Barrett's last name and room number (#211). Burk confirmed that Barrett was staying in room #211 and was unsure if there was anyone else staying in that room with him. Burk said that they had tried multiple times to get him to return to his room and Barrett wasn't complying. Earle said that Barrett was causing too much of a nuisance and asked that we "evict" him.

Ofc. Levinstein had asked Barrett for his identification and Barrett put his hands in the air and pointed at resort staff and said "these guys were awesome." I advised Ofc. Levinstein, who was still talking to Barrett while Ofc. Gundlach ran his license, that Barrett was no longer welcome and we needed to arrange for Barrett to leave. Barrett was slurring his words and was, at times, unintelligible. I heard him say something about how handsome Ofc. Levinstein was. Barrett would say something I didn't understand and then say "I'm done with you" and walk away towards hotel room doors. Barrett had asked if he was under arrest and Ofc. Levinstein told him that he was not but that the hotel had an issue with him knocking on doors and because he seemed to be intoxicated. I asked Barrett to return to his room with us so that he could collect his belongings. Barrett continued to slur his words and I could not completely understand what he was saying. He would repeat himself but I still couldn't understand. Barrett would lean up against the wall while talking to us.

When asked who he was there with, Barrett would not tell us and said that he is very sad every day. He attempted to explain something about someone who had died and spoke more directly to Ofc. Levinstein about this and I did not hear the entire conversation.

Barrett went to the elevator with us and we went to the second floor and to room #211. Earle and Burk met us at the room door and Earle used a master key to open the door. Barrett staggered in the hallway and bumped into a wall and then leaned with his back against it. Ofc. Levinstein told him to come and get his stuff and he said he was not going into the room Ofc. Gundlach stood outside with Barrett and Ofc. Levinstein and I entered the room to check for weapons before allowing Barrett to enter; however he would not enter the room.

I re-entered the hallway and heard Ofc. Gundlach telling Barrett to stay where he was and not walk away. Barrett was walking, and stumbling, towards the elevator and was mumbling that he was going to call his lawyer as he walked away. He mumbled that he was done with us, that he was going to "knock" us out and that he was "real strong". Ofc. Gundlach told him not to leave because he still had his driver's license and Barrett turned around and leaned against the wall and said "it's your call" as Ofc. Gundlach told him that he had to get his stuff because he (Barrett) was leaving. Barrett walked away again as he was saying something that sounded like "Don't fuck with me. I love you. I'm sorry." Ofc. Levinstein brought Barrett's suitcase out to the hallway and I tell him again to get his things and he slurred saying that Ofc. Levinstein is a very good looking guy. Barrett began to walk to the closed door of room 211 and he was told that it wasn't his room any more and so he walked down the hallway to the next room and stopped in front of that door.

Ofc. Levinstein told Barrett to sit down in one of the chairs at the end of the hallway "so that we can figure out who to call" to help Barrett. Barrett did sit but stood up several times. Ofc. Levinstein handed Barrett his phone and told him to call somebody to come and get him and Barrett said "I live here." I asked Barrett if he remembered running around on the third floor trying to get into peoples rooms. He leaned forward and said "I'm wrong. I fucking, I'm wrong. You are right. I get that" and he sat back in the chair. I told Barrett that "the hotel wants you to leave" and Barrett leaned forward, then stood up and said "I'm actually done with this" and walked towards a hotel room door and attempted to use the door handle to open the door. I told him that he no longer had a room at the hotel. Ofc. Levinstein told Barrett to sit down and Barrett said "I fucking live here" and then sat down again.

Barrett's phone rang and Ofc. Levinstein told Barrett to answer the call. Barrett mumbled something about knocking someone out and said that it was his friend Darren calling. He then attempted to shake Ofc. Levinstein's hand and fist-bump him and then lunged upwards towards Ofc. Levinstein as he said "I will knock all you guys out." Ofc. Levinstein told Barrett to sit down as Barrett then reaches out to Ofc. Levinstein with both hands as he is standing up and lunging towards Ofc. Levinstein. Barrett had his back towards me and I was not sure if Barrett had touched Ofc. Levinstein and I began to draw my taser. Ofc. Levinstein pushed Barrett back down into the chair and, as Barrett is sitting back in his chair he grabs at Ofc. Levinstein several times.

I indicated to Ofc. Gundlach and Ofc. Levinstein that I was going to place Barrett into handcuffs for "dis intox" and moved to Barrett's left side as he was sitting in the chair. As I instructed Barrett to place his hands behind his back, he pushed his back further into the back of the chair and put his hands on top of his thighs and tensed his arms. Ofc. Gundlach placed his hand on Barrett's left bicep as I told Barrett to put his hands behind his back and I attempted to apply the handcuffs to Barrett's left wrist and pull his left hand behind his back. Barrett began to pull his left hand away, continuing to tense his arm and leaned forward as if to stand up. Ofc. Levinstein was attempting to control Barrett's right hand and place it behind his back as Barrett was tensing and bracing and attempting to pull away. Barrett was then taken to the ground as Ofc.'s Gundlach and Levinstein retained control of Barrett's arms. Ofc. Levinstein was then able to get Barrett's right arm behind his back and handcuffs were properly applied. Barrett was rolled over onto his right side and then we assisted him into a sitting position before standing him up. Barrett again said something about knocking us out.

I advised NorthComm that Barrett was in custody for the charge of disorderly intoxication and we escorted Barrett to the elevators and to the lobby. We walked Barrett to my marked patrol vehicle and I double locked the handcuffs to prevent tightening. Ofc. Levinstein conducted a search of Barrett's person before Barrett was seated in the back of my patrol car. I placed the property removed from Barrett's person into a paper bag and brought it back to the holding cells with Barrett for processing.

Prior to leaving the resort, I notified Sgt. Frank that we had used force in effecting the arrest (directing Barrett to the ground). He arrived on scene and spoke with me about the incident prior to me transporting Barrett to our holding cells. He confirmed that there were no reported injuries.

Upon arriving at the holding cells, Ofc. Dampier arrived to assist in moving Barrett from my vehicle to a holding cell. Ofc. Dampier took custody of the paper bag of Barrett's personal items and he prepared a PBSO Prisoner Property Receipt after placing the items in an appropriate prisoner property bag. Ofc. Dampier also took photos of Barrett, to include his wrists, and confirmed that he was not injured.

I completed the Probable Cause Affidavit and Arrest paperwork charging Barrett with disorderly intoxication and resisting arrest without violence. During the time Barrett was in the holding cell, his friend, Darren, contacted the Jupiter Police Department and responded to the lobby. Ofc. Levinstein had brought Barrett's suitcase from the hotel to the holding cells. I asked Barrett if we had permission to turn over the suitcase to Darren and he said that we could. Ofc. Levinstein ultimately turned over the suitcase to Darren.

Upon completion of the appropriate paperwork, Ofc. Ferguson arrived in the holding cells to take custody of Barrett and his prisoner property. I assisted Ofc. Ferguson in securing Barrett in his patrol car and he ultimately transported Barrett to the Palm Beach County Jail.

I reviewed my BWC footage and placed markers (with notes) in pertinent portions of the video. This concluded my involvement in this case.

On 08-28-21, at 1532 hrs, I was dispatched, as a back-up unit, to 5 N. A1A (Jupiter Beach Resort) reference a drunk hotel guest. Upon arrival, we were greeted by a hotel employee, who stated there was a hotel guest on the third floor, in an extremely intoxicated state. When I arrived on the third floor, I immediately made contact with a w/m (later identified as Brian Barrett, DOB 02-03-73). Brian appeared to be highly intoxicated. He was very unsteady on his feet, his eyes were glassy and his words were slurred. He also had trouble with carrying on a simple conversation. I was advised by employees that Brian's room was on the second floor and that he was knocking on other room doors and trying to get into those rooms. Brian also apparently committed a battery on a guest, but the guest did not want to lodge a formal complaint.

While standing in the 3rd floor hallway with Brian, Ofc. Collins advised me the resort wanted him trespassed from the location. I advised Brian that the resort no longer wanted him here and that I needed to see his identification. Brian pulled out his wallet, but could not find his identification. I took his wallet and found it for him. Brian then started walking away from us, toward the other end of the hallway (away from the elevator banks). I advised Brian to return to our location. He did so after a short period of time. Brian was then escorted to his room (#211) to retrieve his belongings. At Brian's room, he refused to come in and get his personal belongings. I entered the room with a hotel employee and Ofc. Collins to retrieve the items. I packed up his small suitcase, made sure there was nothing else in the room and the room was secured by the employee. Brian tried entering his room, but couldn't get in, so he walked to the other end of the hallway again. He attempted to open another guest room door on the 2nd floor. I then asked Brian to sit in one of the couch seats; which were in the hallway. I told him we can try and reach a friend or family member to come pick him up. Brian was too intoxicated to leave the hotel on his own. He continued to refuse to call someone and attempted to get up from the seat he was sitting in. I sat Brian back down and provided him with his phone. I, as well as the other Officers on scene, told Brian to call someone to come pick him up. He continued to refuse the suggestions. Brian then stood up again, phone in hand, approached Ofc. Collins and made statements to her, then approached me and began making statements to me. I put my hand on his shoulder and asked him to take a seat and call someone. He then grabbed my hand and told me not to touch him. He walked away from me and again, attempted to enter another guest room. Ofc. Collins was able to get him to sit down again. When he sat, his phone then rang (it was his friend Darren; who was also staying at the hotel). I told him to answer it, but he would not. I then attempted to answer it and Brian did not allow me to do so and told me he was going to "knock me out." He then tried standing up again and tried to reach for my arm to shake my hand. He grabbed my hand and leg, so I pushed his hand away and did not allow him to make further contact with me. I felt the safest place Brian could be, until we had arranged for a ride, was to be seated in the lounge chair. Brian attempted to stand up again, did so, and came at my direction in an aggressive manner. I was able to guide him back down into the chair. Brian continued to become belligerent and refusing to cooperate by allowing use of his phone and attempted to get up several times. Brian got more and more aggravated and made the statement "I'll knock all of you out," several times. A decision was made to place Brian into protective custody due to

As I held Brian down into the chair, one handcuff was secured on his left arm. Brian then became highly aggressive and continued to tense his whole body. It was at this point that I decided to bring Brian to the ground in order to control him. While on the ground, Brian tucked his right arm under his body and refused to place it behind his back. After a few moments, I was able to pry his arm from under him and we were able to secure him completely, with the handcuffs. Brian was now under arrest for disorderly intoxication and resisting arrest. He was then brought downstairs, searched, and secured in Ofc. Collins' vehicle.

Brian was transported to the JPD holding cells for arrest processing without incident.

On 8-28-21, at approximately 1535hrs I arrived at 5 N A1A (Jupiter Beach Resort), in reference to a intoxicated guess who had an altercation with another guest. Upon our arrival employees stated the subject was on the 3rd floor with staff. Ofc. Levinstein, Ofc. Collins, and myself proceeded to the 3rd floor with staff and met the staff who was already with the suspect from the altercation, Brian Barrett.

While on the 3rd floor Barrett was observed to be intoxicated by unknown substances. At this time I had NorthCom run Barrett through FCIC/NCIC, he can back clear out of New York. Barrett was still going to different rooms and trying to get in. Ofc. Levinstein was speaking with Barrett and was able to get him to agree to go down to the 2nd floor so we could retrieve his belongings, from his room.

Upon getting to Barrett's room he would not go in to get his things. Ofc. Levinstein went in the room with hotel staff to retrieve Barrett's belongings. I was with in the hall with Ofc. Collins and Barrett, Barrett's mood would change from happy to angry. Ofc. Levinstein retrieved his belongings and handed his bag to him. Barrett then began to walk the wrong way and stood at another door that was not his room. Barret then sat in a chair at the end of the hall and was asked repeatedly if he had anybody in the area that could pick him up.

While sitting in the chair Barrett began to become angry towards us. He stated that he would knock us out. Barrett then attempted to shake Ofc. Levinstein's hand, and when Ofc. Levinstein would not shake his a hand it appeared that Barrett swung at Ofc. Levinstein. This is when I place my hand on Barrett's left shoulder and forearm as Ofc. Collins attempted to place Barrett into handcuffs. I could then feel Barrett begin to tense and resist our attempts to place him in to handcuffs. It was at this time Barrett was directed to the ground using an arm bar take down.

Once on the ground he continued to resist Ofc. Levinstein by getting his right arm under his body. Ofc. Levinstein was able to get his arm out and we were able to put place him into custody. Barrett was still stating he would knock us out. Barrett was then walked down to Ofc. Collins vehicle and placed in the back seat.

I then got sworn witness statements utilizing my BWC from Justin Earle, Brandon Burk, and Tuckeem Wright.

Earle stated when he got to the third floor Barrett was already contained by Food and Beverage Director Brandon Burke. He stated that he witnessed Burke make threats about hitting officers, acted as he was going to hit officers, and observed him "play' hit the officer.

Burk stated he was the first person from staff to make contact with Barrett. They had received a call from the 3rd floor that a guest was banging on the doors of other guests. He said he believed there was some type of disturbance at the
