REASON FOR STOP:

THEN AND THERE UNLAWFULLY DRIVE AND/OR BE IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE WITHIN PINELLAS COUNTY, FLORIDA WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE, A CONTROLLED SUBSTANCE AND/OR ANY CHEMICAL SUBSTANCE TO THE EXTENT THAT HIS NORMAL FACULTIES WERE IMPAIRED.

A BOLO WAS ISSUED IN REFERENCE TO A BLACK DODGE PICKUP TRUCK POSSIBLY BEARING FL# N2AY50, LAST SEEN TRAVELING NORTHBOUND ON US19 AND SR580. ACCORDING TO THE BOLO, THE WITNESS OBSERVED THE ABOVE DESCRIBED VEHICLE SPEEDING AND SWERVING ALL OVER THE ROADWAY, WHICH ALMOST HIT A BICYCLIST.

DEPUTY FERGUSON ADVISED HE WAS FLAGGED DOWN IN THE AREA OF 2801 EAST LAKE RD IN WHICH HE WAS NOTIFIED ABOUT A BLUE PICKUP TRUCK BEARING FL TAG NQAY50 DRIVING IN A RECKLESS MANNER. DEPUTY FERGUSON CONDUCTED A TRAFFIC STOP AT MARKET PLACE DR AND BARCLAY DR.

I ARRIVED ON SCENE AND MADE CONTACT WITH DEPUTY FERGUSON WHO ADVISED THE DEFENDANT HAD ALCOHOLIC BEVERAGE ODOR EMANATING FROM HIS BREATH.
