The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On the listed date and time, Deputy R. Bungarz (ABN: 251597) contacted the driver of a red Chevrolet Corvette, bearing Florida tag NYUI20 (VIN:1G1Y72D4XL5106818) after receiving an assist motorist call for service. Upon contact with the defendant, the affiant detected the strong odor of an alcoholic beverage emanating from the defendant's breath, observed his eyes to be bloodshot/ watery eyes, and to have unstable balance. The affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. While at CBT, the defendant refused to provide a lawful breath sample after Implied Consent was read and understood. A query of the defendant in DAVID revealed the defendant has a previous DUI and refusal to submit to a lawful breath/urine/blood test (03/08/2020). The defendant was positively identified via his valid Florida driver's license.
