On the **30** day of **July**, **2020** at **15:06** (Specifically include facts constituting cause for arrest.)

On Thursday, July 30, 2020 at 1506 hours, I arrested and charged Brian Grossman, (W/M, D.O.B. 06/06/1978) with one count of Possession of Cocaine Pursuant to F.S.S. 893.13(6)(A).

On the listed date at 1416 hours, Palm Beach Police Communications received a 911 call from Grossman. Grossman reported that he believed someone was trying to break into his hotel room, Brazilian Court Hotel, 301 Australian Avenue, room 101. Upon my arrival, an unidentified hotel staff member stated to me that the guest(s) staying in room 101 had been acting strange since approximately 0600 hours. I then knocked on the hotel room door and identified myself as a Palm Beach Police Officer. Shortly after, Grossman opened the door wearing only a towel around his midsection and was sweating profusely. Furthermore, Grossman had a white substance underneath his left nostril and dilated pupils. Grossman also appeared to be in a manic state of mind and repeatedly told me that there was someone inside the hotel room. Grossman repeatedly asked me to look inside the bedroom to check for someone. When asked if there was anyone else inside the room he state there was a female guest in the bedroom. The female guest was later identified as Crystal Fernandez, (W/F, D.O.B. 09/09/1978). Fernandez was then instructed to exit the hotel room and stand with Officer Agaoglu.

After Fernandez left the bedroom, Grossman instructed me to, "Search the bedroom for anyone else". Upon entering the bedroom, I observed a clear zip lock bag straight in front of me, next to the bedside table, (closest to the bathroom), in plain view. Inside the clear plastic bag was a white powdery substance and white rocks which I know from my law enforcement training and experience to be cocaine. On the opposite side of the bed on the other end table was a Florida driver's license with Grossmans image on it. Located on the FL DL was white powder believed to be cocaine residue. At this time, Grossman was detained and placed in handcuffs behind his back.

Post Miranda, Grossman stated that he was "partying all night" but refused to claim ownership to the cocaine. However, Grossman later stated to a Detective on scene that the white substance in his nose was cocaine. The residue on the bedside table and Grossman's FL DL later tested positive for the presence of cocaine using Sirchia Nark Cocaine ID wipe.

Based on the above facts and totality of the circumstances, Grossman was placed under arrest and charged with one count of possession of cocaine, pursuant to F.S.S. 893.13(6) (A). Grossman was then transported to the Palm Beach Police Department for possessing. While at the PBPD the cocaine was field tested and yielded a positive reaction for the presence of cocaine using the Sirchia Nark Cocaine ID wipe kit. The cocaine in the clear zip lock bag weighed 15 grams and had a total package weight of 28.7 grams. The cocaine found on the bedside table weighed .4 grams and had a total package weight of 9.2 grams. Grossman was then transported to the Palm Beach County Jail without further incident.
