The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 10 day of APRIL, 2020

at approximately 9:35 PM, at 5281 BAMBOO PL UNIT B, in Pinellas County did:

DID WRITE OR COMPOSE, AND ALSO SEND OR PROCURE THE SENDING OF SEVERAL TEXT MESSAGES TO A PERSON KNOWN TO THE DEFENDANT (NON DOMESTIC) CONTAINING A THREAT TO KILL OR TO DO BODILY INJURY TO THE PERSON OR FAMILY MEMBER, TO WIT:

DEFENDANT ENGAGED IN A VERBAL ARGUMENT WITH THE VICTIM AT THE VICTIM'S RESIDENCE. THE VERBARL ARGUMENT TURNED PHYSICAL HOWEVER THERE WERE NO WITNESSES OR VISIBLE INJURIES. THE DEFENDANT FLED THE VICTIM'S RESIDENCE AND CONTINUED TO ENGAGE THE VICTIM THROUGH TEXT MESSAGES. ONE OF THE TEXT MESSAGES STATED "I WILL TAKE YOUR HEAD OFF." MORE TEXT MESSAGES CONTAINED THREATS TO INCLUDE "YOU WILL FIND JESUS" AND "YOU ARE LUCKY YOU STILL HAVE FRONTS IN YOUR MOUTH.... BUT HEY THE NIGHT IS STILL YOUNG." THE VICTIM STATED HE HAD A WELL FOUNDED FEAR THAT THE DEFEDANT WILL SHOW BACK UP AT HIS RESIDENCE AND HAS THE POTENTIAL TO CARRY OUT THE THREATS.

PCSO DEPUTITES SPOKE TO THE DEFENDANT ON HIS PHONE AND HE ADMITTED HE WAS THE ONE WHO SENT THE TEXT MESSAGES. THE DEFENDANT WOULD NOT ANSWER THE DOOR FOR DEPUTIES UPON ATTEMPTED CONTACT AT HIS RESIDENCE.

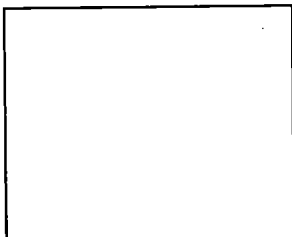
