Upon my arrival I was informed by the witness that she observed the vehicle strike a concrete barrier wall damaging the wall and then continue to drive. The witness also observed the subject exit the roadway and park in a parking lot stepping out of the drivers seat of the vehicle. While speaking with the subject at the scene I noticed several signs of impairment. Upon completing the crash investigation I informed the subject that I would be beginning an investigation for DUI. The subject was then placed under arrest for the charge listed in this document. The subject was transported to Hillsborough County Breath Testing Unit and provided two samples of his breath resulting in .170 and .168 g/210L of breath.
