On the above listed date and time, I Trooper Winter with the Florida Highway Patrol was dispatched by the Tampa Bay Regional Communications Center (TBRCC) for a vehicle crash that occurred on SR-597 (N. Dale Mabry Highway) and Stall Road. I arrived on scene at approximately 2203 hours. I observed V01, a white 2018 Honda Accord Florida license plate number DBB2347 with heavy front end damage. I also observed V02, a flat bed semi truck, attached was a trailer Florida License Plate # 1144CH with right rear end damage. I made contact with Driver 01 who was identified by his Florida Drivers License #D423074922970 Brian Osmar Delcid as well as his passenger Ulysses Delcid (DOB 08/27/2014). At 2246 pm I read Mr. Delcid the Miranda warning from my issued Miranda warning card. Mr. Delcid stated he understood his rights. I asked if he was driving his vehicle. He stated he was the driver and he did crash with his son in the backseat of the vehicle. While speaking with Mr. Delcid indicators of impairment were observed to include (Bloodshot, watery eyes, slurred speech, unstable balance, and the odor of an alcoholic beverage on his breath). Standardized Field Sobriety Exercises were conducted, and impairment was observed. Mr. Delcid was arrested for DUI and refused breath. Mr. Delcid was transported to the Hillsborough County Jail for further booking procedures.
