The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/23/2021, at approximately 2338 hours, I conducted a traffic stop at the intersection of 41 Hw N. and Mirabay Bl. Apollo Beach, Fl. 33572. I conducted a traffic stop on a white in color, BMW(GKUS86/VIN:WBA3T1C55GP822874) due to the vehicle traveling ninety miles per hour in a fifty-five miles per hour zone. When I made contact with the defendant, who was in the driver's seat and the only person in the vehicle, I observed him to have watery/glassy eyes and the odor of an alcoholic beverage emitting from his breath. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant refused to provide lawful samples of his breath after implied consent was read. The defendant was identified via Florida driver's license.
