Marsy's Law has been invoked. On March 5, 2022, this affiant arrested and charged W/M Brian Thomas Moran with one count of F.S.S. 810.08(1) Trespass of Occupied Structure. The details are as follows: On March 5, 2022, at 0316 hours, the Palm Beach Police received several reports of an unknown subject turning and pulling on doors in the 200 block of Australian Avenue. Officers responded and made contact with Reporting Party Raymond Bruce Johnson in apt 3 who stated that while inside his residence located at 226 Australian Ave, he confronted an unknown white male with an Irish accent who had entered his second floor residence, placed an alcoholic beverage down which was within feet of his wallet. The unknown subject began to call out an unknown name, who did not reside in this apartment. The subject left when confronted by Johnson. There was no signs of forced entry. No items were reported stolen. Johnson signed an Affidavit stating his desire to prosecute and he also invoked Marsy's law. Officers then located a white male in the 200 block of Australian Avenue, fitting the description with an Irish accent. This subject was positively identified as Brian Thomas Moran who is visiting from Ireland. Johnson had stated that Moran did not have permission or authority to enter his residence. On March 5, 2022, RP Johnson made an in person positive identification of Moran who was arrested and charged with: 1 count of Trespass of Occupied Structure pursuant to F.S.S. 810.08(1).
