The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On October 19, 2019 at approximately 11:12pm, I was dispatched to a hit and run collision located at SR-574 (MLK JR Blvd) and Orient Road. Upon arrival, I spoke with on scene Hillsborough County Sherriff Office deputies who advised that the suspect vehicle was also involved in another collision located on SR-574 and I-4 (SR-400). I spoke with the victims at the first scene who advised they were able to take a picture of the suspect's attached registration and described the driver as a younger blonde female. The victim advised that the defendant then fled the scene. After I completed my investigation at the first scene, I then traveled to the second scene. Upon arrival I spoke with a Tampa Police Department DUI officer who advised he witnessed the second collision. The officer advised that he went to provide aid to the suspect's vehicle and observed only the defendant in the vehicle. The defendant advised that she was injured and wanted to be transported to the hospital. The defendant was then transported to the hospital by Americare. I then completed my investigation on scene and then traveled to the hospital. Hospital staff advised that the defendant arrived and then immediately left refusing care. I then traveled to the defendant's address where I was able to make contact with the defendant. I then arrested the defendant for Hit and Run and Resisting without Violence due to the defendant utilizing the Emergency Medical Services to delay contact with authorities. I transported the defendant to Orient Road Jail without incident. The defendant was booked for the listed charges.
