The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a white 2019 Hyundai Kona (FL TAG #ICCOY) eastbound on Kennedy Bl W in the left lane. While driving, she drifted out of her lane several times, almost crashing into OFC C. Bishop, while he was also driving eastbound in the lane next to her. During the traffic stop, the defendant was identified via a DAVID photo (she was not in possession of her driver license) and exhibited several clues of impairment, to include: watery/bloodshot eyes, droopy eyelids, slurred speech, she was emotional, had very poor balance, appeared lethargic/sluggish, poor coordination, slow/deliberate movements, admitted to drinking "1 glass of wine and 2 beers" prior to driving, and emitted a strong & distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a very poor performance on SFSEs. While at CBT, she was read Implied Consent, however decided to refuse to provide a breath sample.
