The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was observed to be driving a gray 2017 Dodge Charger (FL TAG #JSZG33) westbound on Kennedy Bl W from Ashley Dr S. While driving, she weaved back and forth in her lane, crossing over the solid lane divider line on both sides of the vehicle several times. During the traffic stop for a reasonable suspicion of driving while ill, tired or impaired, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: watery/bloodshot eyes, droopy eyelids, blank/dazed stare, slurred speech, emotional, poor balance, admitted to drinking "Truly" (Alcoholic Seltzer Water) prior to driving and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a poor performance on SFSEs. While at CBT, she provided 2 valid breath samples, measuring .115/.110 BrAC.
