On Tuesday, April 14, 2020, at approximately 2230 hours, I arrived to [REDACTED] in reference to a battery that occurred at 15934 Temple Blvd, in Loxahatchee, FL 33470.

Upon arrival, I made contact with Samantha Porath, who advised to me that she had her cell phone taken and she was hit by two individuals at a pool party. Porath stated in an audio sworn statement that she arrived at a pool party at 15934 Temple Blvd., Loxahatchee, with a friend, Haley Thompson, in the evening. While at the party, she saw two acquaintances, personally known to her, as Anthony Cender and Brianne Costen. Both Cender and Costen are in a relationship. Porath stated that an argument started when Costen was upset with her and stating that she was trying to take Cender from her, at approximately 2100-2130 hours. The argument escalated, which is when Cender pushed Porath, causing her to fall to the ground. Porath stated that Costen then got on top of her and started hitting her. Porath advised that Cender had stomped on her several times. Both parties were eventually separated. Porath stated that she noticed that her phone had been lost in the physical altercation, which is when she saw Cender pick up the phone off the ground. Porath stated she asked for her phone back, which is when she saw Cender walk away with it and then claim that he did not have it. Porath stated she never received her phone back.

Thompson, witness to the altercation, provided me with an audio sworn statement of the events stating that Cender and Costen battered Porath, and that Cender deprived her of cell phone. This sworn statement coincided with Porath's statement.

Video was captured of the incident and uploaded to Snapchat. I reviewed the video where it is seen that Cender pushed Porath into a speaker, causing her to lose balance. While off-balance, Costen immediately closed distance to Porath, throwing several closed-fist punches striking her in various areas of her body and face. Costen and Porath then go to the ground, where Costen then gets on top of her, continuing to throw closed-fist punches.


Upon observing Porath for any signs of marks or injuries, I was met with positive results. Porath had swelling and lacerations to her face and lip, blood in her hair, redness and abrasions to her front torso/stomach region, and bruising and raising of the skin to the right forearm. Photos were taken of the injuries.

I made contact with Costen, who was read Miranda. Post-Miranda, Costen stated that she got into a physical altercation with Porath and did make contact with her.

Based on the injuries on Porath, the recorded video on Snapchat, and both Porath's and Thompson's sworn audio statements, I find Brianne Costen in violation of F.S.S. 784.03(1a1) - Simple battery.
