at approximately 2:08 AM, at 6741 4TH AVE N, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE BRYCE GONZALEZ, HER BOYFRIEND AND CO-HABITANT, AGAINST THE WILL OF BRYCE GONZALEZ, TO-WIT: THE DEFENDANT STRUCK THE VICTIM SEVERAL TIMES IN THE HEAD WITH A CLOSED FIST AND CAUSED A VISIBLE INJURY TO THE VICTIM'S RIGHT EYE. THE DEFENDANT ALSO SCRATCHED THE VICTIM CAUSING VISIBLE INJURIES TO THE RIGHT SIDE OF THE VICTIM'S NECK AND UPPER LEFT PORTION OF HIS BACK.

THE DEFENDANT AND VICTIM HAVE BEEN IN A ROMANTIC RELATIONSHIP FOR TWO YEARS AND CURRENTLY LIVE TOGETHER AS A FAMILY. THE DEFENDANT FOUND THE VICTIM KISSING HER FRIEND AND SHE STRUCK HIM IN THE FACE SEVERAL TIMES WITH A CLOSED FIST. THE PHYSICAL ALTERCATION CONTINUED AND THE VICTIM SUSTAINED SCRATCH MARKS ON THE RIGHT SIDE OF HIS NECK AND UPPER LEFT PORTION OF HIS BACK.

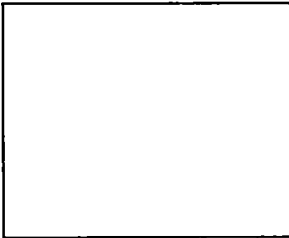
