The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On Thursday, October 15, 2020 approximately 3:31 am, I Trooper Warren Reid was dispatched to a traffic crash which occurred on Interstate 4, just east of Interstate 275 involving the defendant's vehicle which traveled off the roadway to the right, struck the concrete barrier and overturned. When I arrived on scene, I observed the defendant standing at the driver's door of the vehicle crying. I was later informed by a Road Ranger who arrived on scene shortly after the crash and observed the defendant sitting in the driver's seat.
 After I completed the crash report, I informed the defendant that I had concluded the crash report and was now conducting a criminal investigation for DUI and read her the Miranda Warning. I informed the defendant that the reason for this investigation was due to the strong odor of consumed alcohol emitting from her breath. I also observed her watery eyes and not able to maintain proper balance. I then transported the defendant to a nearby parking lot to perform the Field Sobriety Exercises.
 During the Horizontal Gaze Nystagmus, I instructed the defendant to follow the stimulus light with her eyes only, but she continued to turn her head each time the light passes. During the Walk and Turn, the defendant was unable to follow the directions given, failed to walk heel to toe, raised her hands to balance, and failed to complete the walk. During the One Leg Stand, the defendant was unable to maintain balance, held out her hands to the side and kept putting her feet down. I then informed her that she was under arrest for DUI. She was handcuffed behind her back, double locked and placed in the back seat of my patrol car. Defendant was later removed from the car and searched after a female officer arrived on scene. The defendant was then transported to the Orient Road Jail and taken to the breath testing center to provide a breath sample. This offense committed in Hillsborough County.
