<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/16/2020 at approximately 0330 hours, the defendant was operating a black 2014 Ford Edge with Ohio tag HHU7651 northbound on Florida Av N approaching the intersection with Hillsborough Av when she rear ended a unknown vehicle. The vehicle the defendant struck left the scene and the defendant continued traveling northbound on Florida Av. As she approached the intersection of Henry Av, the vehicle exited the roadway, struck a one-way street sign and came to a rest.</p> <p>Contact was made with the defendant who was seated in the drivers seat of the vehicle which was still running. The vehicle is a push to start and the keys were later located in the small backpack the defendant was carrying at time of contact. The defendant exhibited multiple indicators of impairment including slurred speech, difficulty forming sentences, and glassy eyes. As the defendant exited the vehicle she utilized either the vehicle or a nearby wall for support as she could not stand on her own. After being read her Miranda Rights, she declined to answer any questions or participate in a DUI investigation and she was subsequently arrested.</p> <p>After being read implied consent, she declined to provide a breath sample. The defendant was positively identified via passport photo.</p>
