 On the above stated date and time the victim dropped an envelope containing \$1804 in cash after exiting his vehicle in the parking lot of Suncoast Schools Credit Union 17505 NORTH PALMS VILLAGE PL. The Co-defendant then after using the ATM picked up the envelope and entered the passengers side of the vehicle being operated by the Defendant. The Defendant and Co-Defendant then fled the scene with the victim's money, thereby depriving him of his property and made no attempt to turn in the money to law enforcement, the bank, the victim, or anyone else. In a post Miranda warning confession the Defendant admitted to splitting the victim's money evenly with the Co-Defendant after discussing what to do with it. The Defendant was identified both verbally and via FL DL.
