The victim stated the following: She had come over to her brother in laws residence (witness), in order to pick up medication to bring to Peru on an upcoming trip. While there, her niece (suspect), who is the witness's daughter and lives there, arrived home and began arguing with her. She advised that she and the suspect have not had the greatest relationship in the past. The victim stated that she was sitting in the living room with the witness, eating dinner while the suspect was in the kitchen. She stated that the suspect continued calling her derogatory names and she tried ignoring it until it became too much. The victim then advised that she got up from the couch and began walking toward the kitchen, and as soon as she took a step in the kitchen, the suspect threw the contents of her drink, not the glass, in her face. She advised that she then walked away and called the Police. I observed the victim's shirt to be soaking wet from the chest up. I photographed the victim and her shirt.

The witness stated the following: He asked the victim to come over to pick up medications. He advised that while the victim was there, his daughter (suspect) arrived home and began an argument with the victim. He stated that the suspect was being verbally aggressive toward the victim. He advised that the argument continued to escalate and the victim got up from the couch and walked into the kitchen, where the suspect was located. He stated that as soon as the victim entered the kitchen, the suspect threw her drink at the victim. He advised that the victim and suspect have had animosity in the past, but it has never become physical before.

The suspect stated the following: When she arrived at home, she observed her aunt (Victim) inside of her residence which aggravated her. She advised that she does not like that her dad is spending time with her aunt. She stated that they both began arguing to the point that her aunt got up from the couch and began walking towards her in the kitchen. She advised that she felt threatened because the victim was walking into the kitchen. She stated that she threw her drink in her face to defend herself.

Based upon my above described investigation, I determined that Brittany Moore was the primary aggressor in the domestic altercation. I found probable cause to charge Brittany Moore with DOMESTIC BATTERY, as she did actually and intentionally touch or strike Geraldine Campos against her will, and was a family or household member with Geraldine Campos, contrary to Florida Statute 784.03(1) and 741.283. (1 DEG MISD).
