The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 4/2/2021, at approximately 0310 hours, Deputy T. Ryan ABN 257245 conducted an investigatory traffic stop at Sheldon Rd / Linebaugh Av W on a black Ford bearing FL tag 3LV1S (VIN:3FA6P0H74GR222757) after being dispatched to a disturbance call for service in the immediate area. Deputy Ryan observed the defendant operating the vehicle, to be the sole occupant, and detected signs of impairment. Affiant responded to the scene, detected an odor of an alcoholic beverage emanating from the defendant's breath, her eyes were bloodshot and glassy, her speech was slurred, and she was unsteady on her feet. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide a lawful breath sample to determine her breath alcohol content (BrAC). Breath Technician Pequignot ABN 255300 provided me with the defendant's BrAC results and they are follows: First BrAC sample (.226) ; Second BrAC sample (.226). The defendant was identified via FL DL. The defendant was given a DUI citation A6UW2PE which reflects the DUI charge.
