at approximately 10:21 PM, at TAMPA RD & SHADY OAKS DR, OLDSMAR, in Pinellas County did:

REASON FOR STOP: WHILE ASSISTING PCSO DEPUTY JAMES WILHELM ON A TRAFFIC STOP NEAR THE INTERSECTION OF TAMPA RD & SHADY OAKS DR, I OBSERVED A SILVER FORD EXPLORER BEARING FLORIDA TAG CXHX32 TRAVEL PAST OUR MARKED PATROL VEHICLES AT A HIGH RATE OF SPEED. IT SHOULD BE NOTED DEPUTY WILHELM'S PATROL VEHICLE EMERGENCY LIGHTS WERE ACTIVATED AT THAT TIME AND MY REAR OVERHEAD DIRECTIONAL LIGHTS WERE ALSO ACTIVATED. DEPUTY WILHELM'S VEHICLE AND MY VEHICLE WERE FACING EASTBOUND. THE SILVER FORD EXPLORER WAS ALSO TRAVELING EASTBOUND. THE SILVER FORD EXPLORER DID NOT YIELD TO OUR EMERGENCY VEHICLES, DID NOT SLOW DOWN TO A SPEED 20 MPH LESS THAN THE POSTED SPEED LIMIT, AND DID NOT VACATE THE LANE CLOSEST TO OUR VEHICLES.

THEN AND THERE UNLAWFULLY DRIVE AND/OR BE IN ACTUAL PHYSICAL CONTROL OF A SILVER FORD EXPLORER BEARING FLORIDA TAG CXHX32 WITHIN PINELLAS COUNTY, FLORIDA WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE, A CONTROLLED SUBSTANCE AND/OR ANY CHEMICAL SUBSTANCE TO THE EXTENT THAT HER NORMAL FACULTIES WERE IMPAIRED.

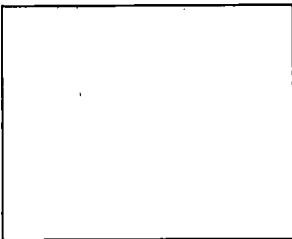
