PROBABLE CAUSE	<p>On Monday, July 19, 2021 at 0306 hours Mike Heeney called 911 in reference to a domestic battery that was occurring in his presence at the corner of Datura Street and Olive Ave. He stated that there was a black male that was later identified as Schneider St Fleur involved in a verbal argument with his girlfriend, Brittany Fortier. Heeney advised via telephone that St Fleur was screaming at Fortier and the verbal argument then escalated when St Fleur grabbed Fortier and began to drag her across the street. Heeney also stated that Fortier was with a group of girlfriends, and they asked Heeney to help Fortier.</p>									
	<p>Heeney stated that observed Fortier crying and pleading with Fleur to stop and let her go. He believed that Fortier was in serious danger with Fleur.</p>									
	<p>As I was arriving to the scene at 0309 hours, I could see and hear Fleur screaming at Fortier. He was yelling profanities towards her and told her that he was leaving her at this location. I exited my patrol vehicle and made contact with all parties, Heeney, Fleur and Fortier. Fleur was sweating and very upset, he was jumping around and being aggressive towards Fortier. Fortier was crying, her face was covered in sweat, tears and mucus from her nose.</p>									
	<p>Fleur came walked up to my location and was attempting to tell me what happened. But, he was screaming at me and Fortier. I had to keep backing up from Fortier. I had to tell Fortier that he did not need to stand so close to me. Fortier stated that Fortier is his girlfriend and they live together. He stated that she is drunk and she is leaving her and going home. Fleur then walked away from my location.</p>




<p>any friends. I told her that I believed that she should find a different place to stay for the night. Fortier stated she does not have any friends. I asked her, "what about your friends you were with tonight?" She repeated that she does not have any friends. Then she stated that she wanted to go home to her apartment because she pays for the apartment.</p> <p>At this time, Fleur came back to our location and interrupted my conversation with Fortier. I repeated told Fleur to stop talking so that I could speak to Fortier. He would not stop talking. At this time Ofc Rubio responded to the scene. Fleur would not stop talking. Fortier and I then walked away from Fleur so that I could speak to her. I asked her if she wanted to leave with Fleur. She stated yes. I told them to leave the area.</p> <p>Fortier began to walk southbound on Olive Ave. Fleur then turned his aggression towards me and began to yell profanities at me and tell me "you look stupid as fuck!" I repeated told Fleur to leave. I yelled at Fleur to leave the area. He got into my face as he was screaming at me and hit my chest and camera with the back side of both of his hands. He then bumped his chest into me. I then pushed him back and gave the command to leave. He backed up.</p> <p>At this point Fleur was escalating our contact. For all of our safety, Ofc Rubio, Fleur and myself, I removed my TASER 7 from the holster, turned it on and pointed at Fleur. Ofc Rubio did the same. Fleur complied with my commands and backed up. Then Fleur got down on his knees. Ofc Rubio and I are still telling them to leave the area.</p> <p>Then Fortier comes back to our location, she runs at me and hit me with her right hand while holding her cellular phone. I back up and tell Ofc Rubio to back up. Fortier phone fell on the ground. Fleur then grabs Fortier and pulls her southbound on Olive Ave. He is screaming at her and telling her that all of this is her fault. Fortier has become very aggressive now toward the police.</p> <p>Fortier had just committed battery on a law enforcement officer. But, to defuse the situation I told Ofc Rubio to back up. I also returned by TASER to the holster. Fleur then walks back towards Ofc Rubio and I and pick up her phone. He is screaming at me about the situation. Fleur keeps yelling that he will win a million dollar lawsuit against me and the City of West Palm Beach.</p> <p>Fleur actually says that I am smart because I am backing away from his location. He is still in holding on to Fortier. He keeps repeating that I am smart cause I'm backing away. Then Fleur yells "but I don't mind making a million dollars off you!" he then throws Fortier to the ground and begins to walk towards me in a very aggressive manor.</p> <p>Fleur just committed domestic battery in my presence and assault on a law enforcement</p>




	<p>officer. I then deploy my TASER 7 and the two probes strike Fleur on the chest. The TASER did not have a direct affect, so I deployed the TASER a second time. Fleur then fell to the ground.</p> <p>Fortier was still laying on the ground and realized that Fleur was tased. She jumped up and began to run towards my location. She swung her purse at me and it struck me on the left side of my head. Then she open hand hit me with her left side of my head and face. I was able to push her away from me, I was still trying to control Fleur. Fortier began to get up to attack me again. Ofc Rubio then deployed her TASER to control Fortier. Fleur then attempted to get up and assist Fortier. I then deployed one more cycle of my TASER. Fleur complied and did not attempt to stand up.</p> <p>Other West Palm Beach Units arrived, and Fleur and Fortier were arrested. Based on the events probable cause exists to charge Fleur with domestic battery and assault on a law enforcement officer. Fortier was charged with battery on a law enforcement officer and resisting arrest without violence.</p> <p>I sustained injury to my forehead and left side of face. The index finger on my left had was scratched and was bleeding. My left knee was twisted during the altercation and I appears to have internal damage. Photographs were taken of all parties. Both Fleur and Fortier were transported to St Mary's Hospital for medical clearance then to the Palm Beach County Jail.</p>
