The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a silver 2013 Hyundai Elantra (FL Tag #DVZE30) southbound on Howard Av S from Platt St W.
 This section of Howard Av S is a 1-way road with northbound traffic only.

During the traffic stop for the wrong way infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, slurred speech, fumbling fingers, poor coordination, poor balance, she admitted to drinking a mixed cocktail prior to driving, and emitted a distinct odor of an alcoholic beverage from her breath.

The defendant was arrested for DUI following a poor performance on SFSEs and transported to booking.

While at CBT, the defendant said that she did not want to take a breath test, so I read her Implied Consent. When asked again, she initially said that she would, but then changed her mind again during the 20 minute observation period and decided not to provide a breath sample.
