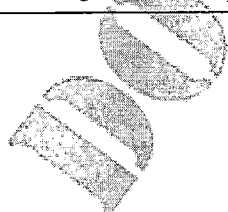

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did on the listed date and time; the defendant and victim were involved in a verbal altercation at their shared residence of 11428 Ivy Flower Lp Riverview, FL. The defendant exited the residence via the garage door and the victim locked the manual garage door behind her. The defendant began pounding on the door demanding to be let back in. When the victim opened the door, the defendant grabbed the victim by his shirt collar and began dragging him out of the house. A brief struggle ensued and the defendant fell backwards with the victim landing on top of her. Both parties got up and the defendant struck the victim multiple times on the face with a closed fist. Both subjects reentered the residence through the garage door and continued fighting. The victim repeatedly attempted to push the defendant away, but the defendant struck the victim approximately three to four more times with a closed fist. The victim suffered minor scratches and abrasions to his face. The victim and defendant have been in a dating relationship for approximately two years and they share a common child. The victim positively identified the defendant as his girlfriend, Brittany McConnell. Brittany McConnell's identity was verified via her Florida driver's license photo. Due to the nature of the defendant's crime, she does not qualify for the Adult Pre-Arrest Diversion Program.
